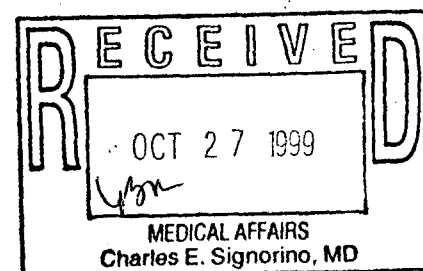

SUBJECT:           ABORTION SERVICES

**BACKGROUND**

The Department of Health Services (DHS) Medi-Cal fee-for-service (FFS) program has rescinded Policy Statement 82-5 and has issued Policy Statement 99-08 (Enclosure I), which states the policy of DHS with regard to abortions performed in the FFS Medi-Cal program. The purpose of this policy letter is to clarify for all Medi-Cal managed care plans (hereafter referred to as the Plans) their contractual requirements regarding the delivery of abortions.

**POLICY**

Abortion is covered by the Medi-Cal program as a physician service. Abortion is, by definition, a sensitive service. All Plans must implement and maintain procedures that ensure confidentiality and ready access to sensitive services for all members. Plan provider networks must include providers of abortions, or Plans must arrange and pay for abortions from nonnetwork providers. Beneficiaries may not be charged for abortion services. Plans may not require medical justification and/or prior authorization for abortion. However, Plans may require prior authorization for provider requests for inpatient hospitalization for the performance of an abortion. Plans must educate both network providers and members regarding abortion policy and procedures. Plans must hold their providers accountable for ensuring that Medi-Cal policy on abortion is honored.



Subject: POLICY STATEMENT 99 08: Abortion

## POLICY:

Effective Immediately Policy Statement 82-5 is rescinded and Policy Statement 99 08: is issued.

The policy of the Department of Health Services with regard to abortions is as follows: Abortion is covered by the Medi-Cal program as a physician service. Medical justification and prior authorization for abortion is not required. However, inpatient hospitalization for the performance of an abortion does require prior authorization under the same criteria as other medical procedures as set forth in Title 22 CCR Section 51327.
