## PROPOSED STATE PLAN AMENDMENT 23-0039 REGARDING SUPPLEMENTAL PAYMENTS FOR HOSPITAL OUTPATIENT SERVICES TO ELIGIBLE HOSPITALS IN THE HOSPITAL QUALITY ASSURANCE FEE PROGRAM UP TO THE FEDERAL UPPER PAYMENT LIMIT

This notice provides information of public interest that the Department of Health Care Services (DHCS) proposes to submit State Plan Amendment (SPA) 23-0039. Proposed SPA 23-0039 will amend supplemental payments to eligible hospitals that meet specified requirements and provide hospital outpatient services to Medi-Cal beneficiaries for the period of January 1, 2024, through December 31, 2024, which were authorized by SPA 23-0008. Proposed SPA 23-0039 is contingent on the results of the retroactive revisions of the Upper Payment Limit (UPL). The nonfederal share of these supplemental payments is funded by California's Hospital Quality Assurance Fee (HQAF), in accordance with Section 3.5 of Article XVI of the California Constitution and the Medi-Cal Hospital Reimbursement Improvement Act of 2013 (California Welfare and Institutions Code section 14169.50, et. seq.).

Supplemental payments provided to hospitals would be up to the aggregate UPL for the period of January 1, 2023, through December 31, 2024. The proposed SPA would allow payment to be on a lump-sum quarterly basis and would not be paid as individual increases to current reimbursement rates for specific services.

Payments to eligible California private hospitals would supplement, and not supplant, existing levels of payments. Additionally, the payments would be subject to all applicable federal payment requirements and limits.

At the time of this notice, DHCS is not able to provide an estimated fiscal impact for this SPA since the UPL calculation for calendar year 2024 is subject to retroactive revisions in accordance with the Centers for Medicare & Medicaid Services (CMS) State Medicaid Letter #13-003. Retroactive revisions to the UPL have not yet been developed. DHCS will include estimated supplemental payment amounts in the proposed SPAs upon submission to CMS.

The effective date of the proposed SPA is January 1, 2024. All proposed SPAs are subject to approval by CMS.
