This change without regulatory effect is pursuant to the recent enactment of AB 396 (Chap. 394, Stats. 2011) which added sections 14053.8 and 14053.9 to the Welfare and Institutions Code. These new provisions require Medi-Cal eligibility to a juvenile inmate that is receiving inpatient hospital services at a medical institution off the grounds of the correctional facility.

OAL approves this change without regulatory effect as meeting the requirements of California Code of Regulations, Title 1, section 100.

## **Regulation Text**

(1) Amend Section 50273(c) to read as follows:

(c) The following individuals are not considered inmates of a public institution and shall be eligible for Medi-Cal provided that all other requirements for eligibility set out in this chapter are satisfied:

(1)(A) - (E) - No Changes

(2) - (7) – No Changes

(8)(A) - (C) - No Changes

(9)-(11) – No Changes

(12) An individual under 21 years of age, who is receiving <u>acute inpatient hospital</u> <u>services and/or</u> inpatient psychiatric hospital services while an inmate of a public institution.
