# **CalEVV Visit Capture Made Simple for Providers and Caregivers**

## **Two Easy Ways to Capture Every Visit**



#### What is a Visit?

A visit is a service provided during an in-person encounter to a client in a home or community-based setting.


CalEVV is a system under which visits conducted as part of personal care and home health care are electronically verified. Providers capturing visit data should ensure that each visit is verified by including all six (6) required data elements, resulting in a complete visit:

- ✓ Type of service performed
- ✓ Individual receiving the service
  - ✓ Date of the service
- ✓ Location of service delivery
- ✓ Individual providing the service
- ✓ Time the service begins and ends

## **NEW** Sandata Mobile Connect (SMC) 2.0



- SMC 2.0 is a free application that can be downloaded to any smartphone or tablet through the Google Play or Apple Store.
- Wi-Fi is not required to use the SMC application. The SMC will continue to capture CalEVV visit data and save it for upload once an internet connection is available.

The previous version of the SMC app (1.0) has been discontinued and will no longer be able to capture data. CalEVV users utilizing the mobile application to collect visit data must use the latest SMC version 2.0.

# **CalEVV Telephonic Visit Verification (TVV)**



- TVV can be used to capture CalEVV visit data instead of the mobile application.
- Allows for capturing visit details from any touch tone phone such as using a mobile or landline phone to dial-in.
- A providers' Welcome Kit contains information on how to call in and what codes to use.
