
Electronic Visit Verification (EVV) Provider Type, Procedure and Place of Service Codes

In California, Medi-Cal (also known as Medicaid) Electronic Visit Verification (CalEVV) is a telephone and computer-based solution that electronically verifies when in-home service visits occur for Personal Care Services (PCS) and Home Health Care Services (HHCS).

All EVV systems must electronically verify the following six visit data elements:

- (1) Type of service performed;
- (2) Individual receiving the service;
- (3) Date of the service;
- (4) Location of service delivery;
- (5) Individual providing the services; and
- (6) Time the service begins and ends.

CalEVV is required for the following rendering Medi-Cal provider types (**enrolled, contracted or sub-contracted**) using the procedures codes identified below.

NOTE: DHCS may amend this document at any time as a result of federal requirements.

Exclusions:

- A “Live-in Caregiver” is a caregiver who regularly remains in the recipient’s home for more than 24 hours at a time and provides any of the authorized PCS and HHCS. Please see the [CalEVV Live-In Caregiver Exemption Guidelines](#) for more information.
- Dual Eligible Plans or Medi-Medi plans for both HHCS and PCS that are primarily paid by Medicare and/or Other Health Coverage (OHC).
- HHCS or PCS that do not require an in-home visit.
