1) Cost Report Tracking Section (CRTS)

Fiscal Intermediary (FI) Updates:

3) Fair Share Reimbursements

 As of July 3, 2024, DHCS has proportionately returned fair share reimbursements and surplus funds from FY 2016-17 through 2021-22 to LEA BOP Providers using Remittance Advice Detail (RAD) Code 728. Payments were processed the week of July 3, 2024, and LEAs should have already received the payments. LEAs that were under-collected and thus did not contribute their fair share will not receive part of the surplus.

4) Interim Settlements

- Although withholds should not be applied to Interim Settlement Payments, DHCS is aware that withholds were erroneously applied to recent Interim Settlement Payments that were processed using RAD Code 709.
- DHCS has temporarily put a hold on issuing interim settlements to avoid further withhold collection from the interim settlements. DHCS is working to exclude RAD Code 709 from the administrative withholds and will release interim settlements for the FY 22-23 CRCS period once the issue is resolved.
- This change is scheduled to be implemented on October 28, 2024.

5) Five Percent Administrative Hold

- DHCS is working with the FI to remove the 1 percent withhold and to increase the 2 percent withhold to 5 percent as a requirement of AB 483. Effective date for this policy will be July 1, 2024.
- This change is scheduled to be implemented on October 28, 2024.
- 6) Update to Current Local Educational Agency Medi-Cal Billing Option Program (LEA BOP) Rates
 - DHCS is working with the FI to update the current LEA BOP reimbursement rates with the new rebased reimbursement rates for LEA BOP services. The current rates will be implemented by October 2023, with an effective date of July 1, 2024.
 - Once the rates are updated, payments from July 1, 2024, onward will be reprocessed at the new rates.

Program Updates:

7) Online Program Guide – Assembly Bill (AB) 483

- The LEA BOP website has transitioned into an online Program Guide for FY 2024-25 and forward.
- The online Program Guide was published and live on July 1, 2024, for all participating Local Educational Agencies (LEAs), charter schools, and community colleges.
- DHCS shall only adopt a revision of the Program Guide after providing 30 calendar days' written notification (by electronic mail) of the revision, including a statement of justification, to all participating LEAs and stakeholders. Please note, when revisions are necessary to reflect changes required by state or federal law or mandated by the Centers for Medicare and Medicaid Services and those changes require immediate action, DHCS may provide less than 30 calendar days' written notice.
 - A 30-day notice e-mail was sent to all LEA BOP providers on May 31, 2024.
- Previous Program Guides are archived and available on the LEA BOP website.

8) Electronic Cost Reporting System Process

• DHCS has unexpectedly encountered internal challenges resulting in the delay of the electronic reporting process. DHCS aims to transition to the electronic cost reporting process for the FY 2024-25 cost report, which is due March 1, 2026.
