# 2) Update to Current Local Educational Agency Medi-Cal Billing Option Program (LEA BOP) Rates

- As of September 23, 2024, the rebased rates for FY 2024-25 have been implemented in the claims processing system. Therefore, claims are being paid out with the new rates.
- The LEA Billing Codes and Reimbursement Rates (loc ed bil cd) section of the LEA BOP Provider Manual is now updated to reflect the rebased interim rates. These rates are also now published on the LEA BOP website.
- An Erroneous Payment Correction will be issued in order to reprocess any claims that were submitted from July 1, 2024, through September 23, 2024, with dates of service July 1, 2024, and forward with the new rates.

### 3) Erroneous Withhold on Interim Settlements

- DHCS is continuing to work on the erroneous withholds that were applied to interim settlement payments processed using RAD code 709.
- Removal of the withholds from RAD Code 709 is scheduled to be implemented in November 2024.
- DHCS is currently exploring the option to return the funds erroneously withheld from the Fiscal Years (FYs) 2020-21 and 2021-22 cost report back to the LEAs through the final settlement process. This would allow DHCS to return the funds in the most expedient manner. DHCS will provide updates at Quarterly Meetings.
- Interim settlements for FY 2022-23 that were paused while the erroneous withhold issue was resolved will be issued between January 1, 2025, and March 1, 2025, once DHCS ensures that the withholds were removed from RAD Code 709.
