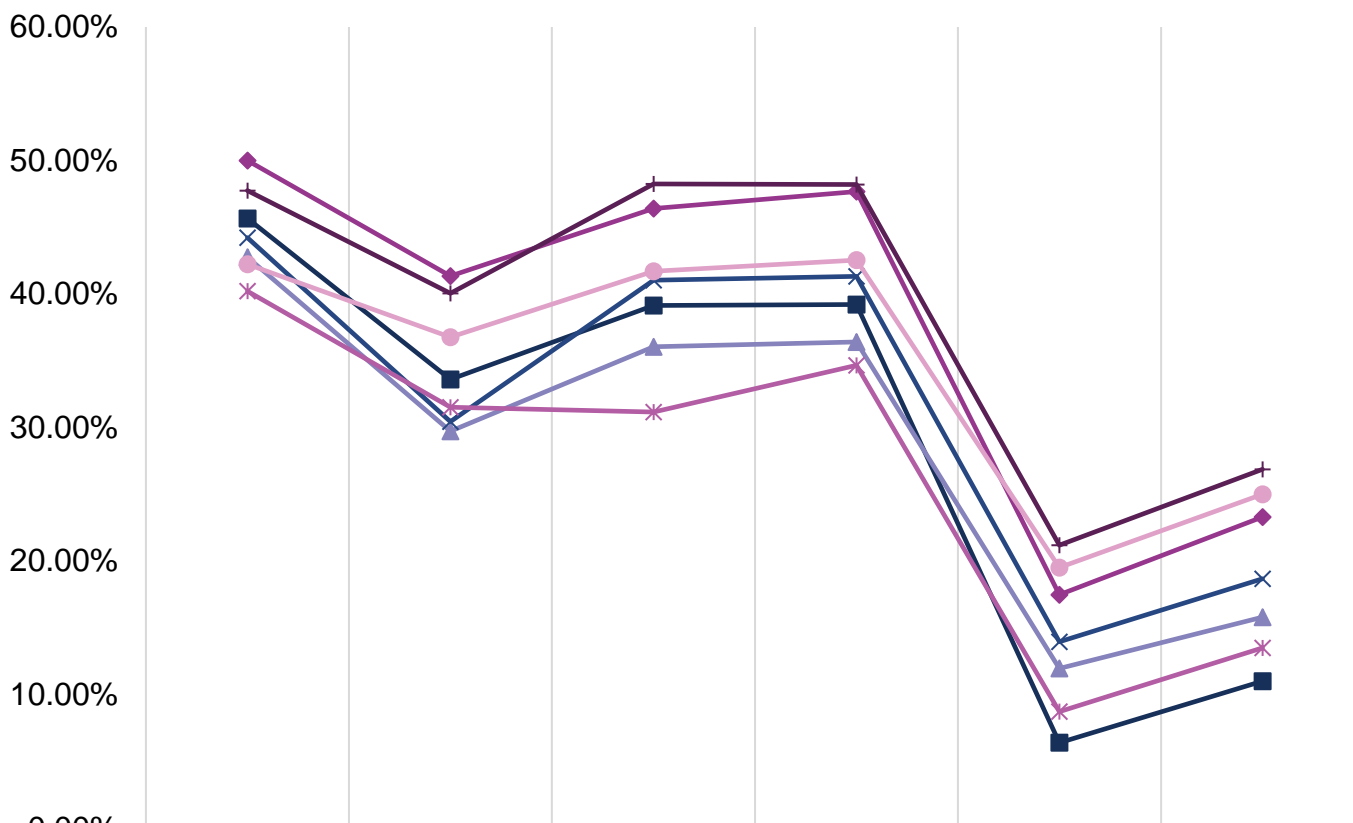


Dental Utilization in Children Ages 0-20

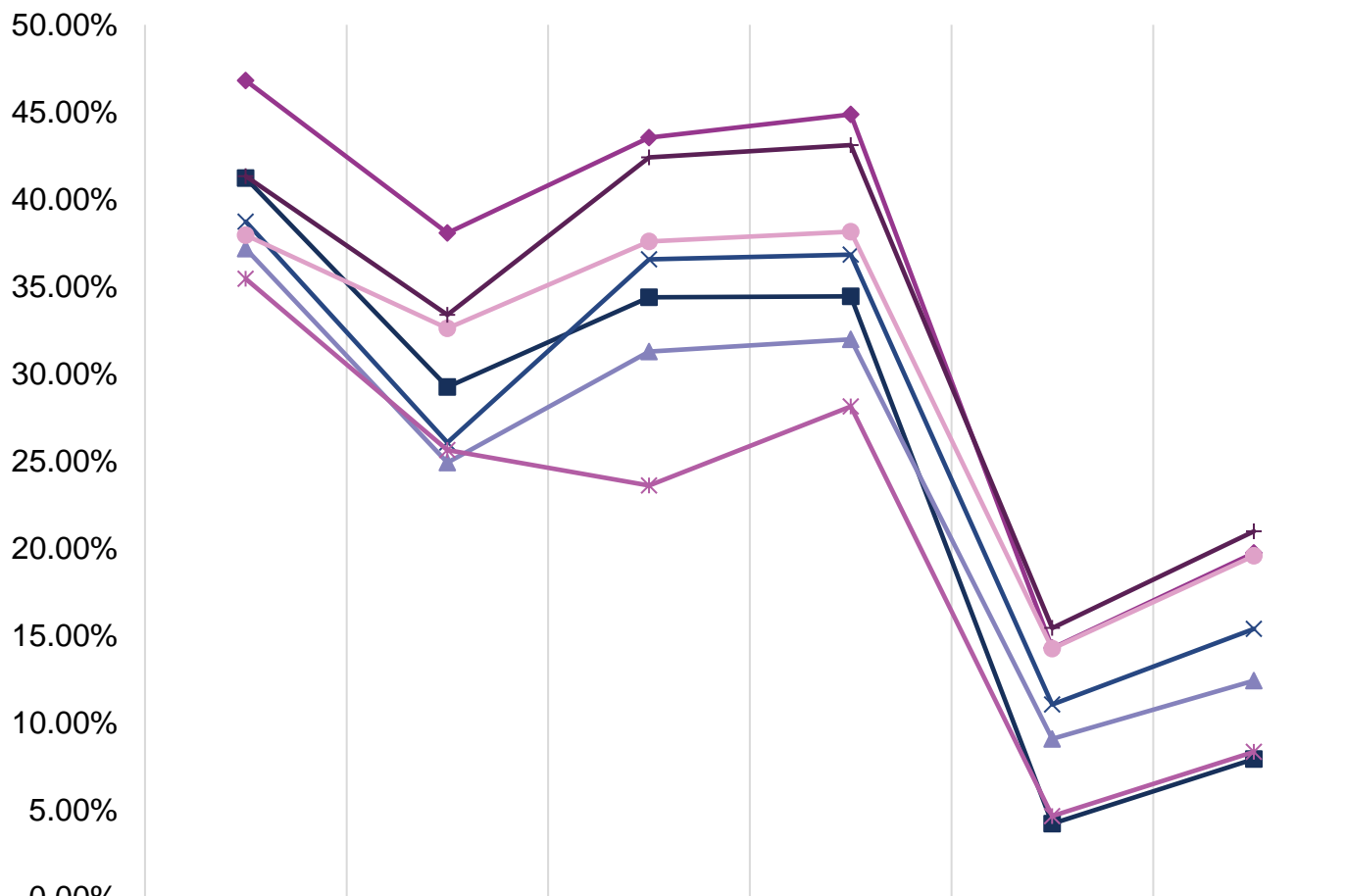

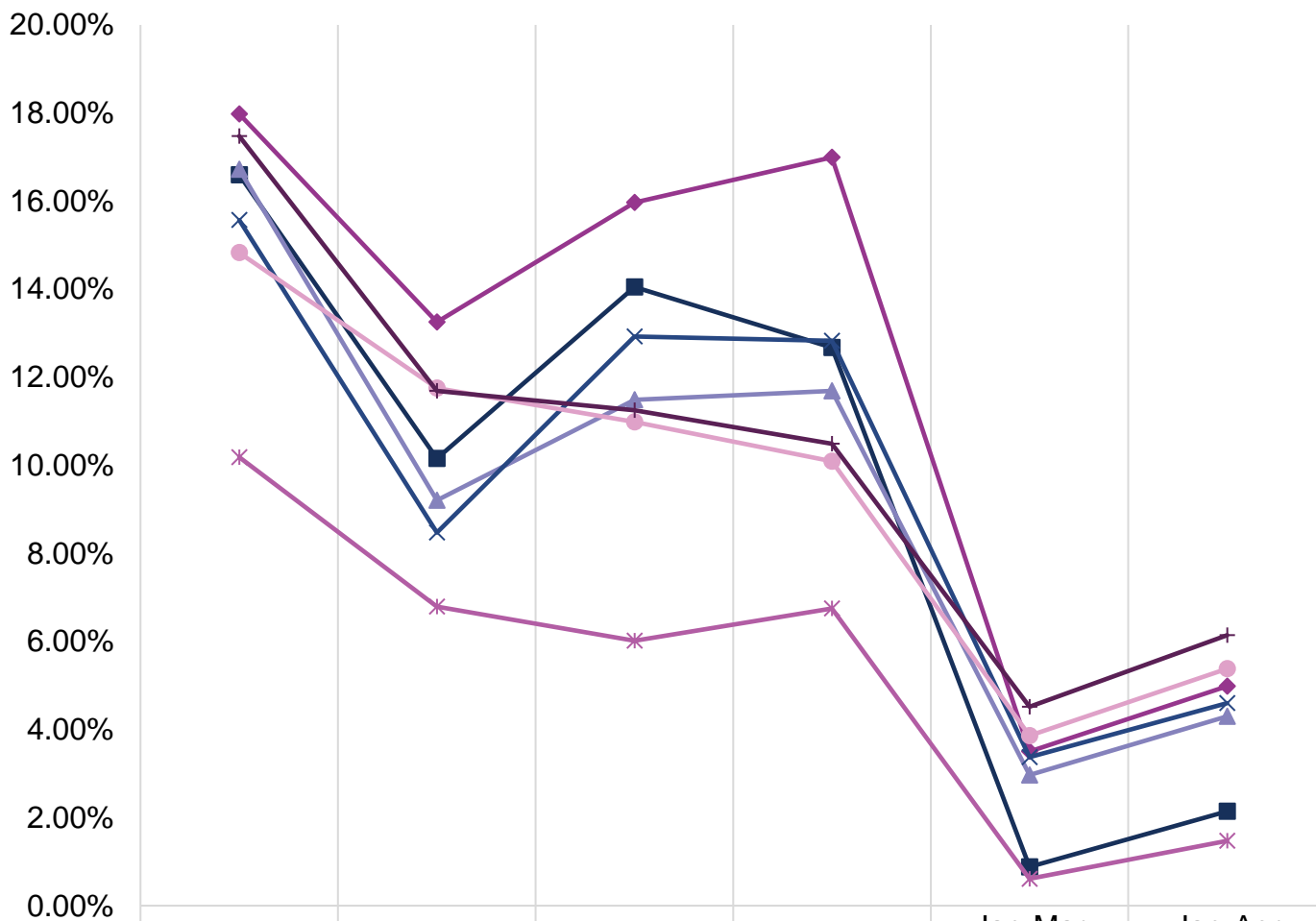

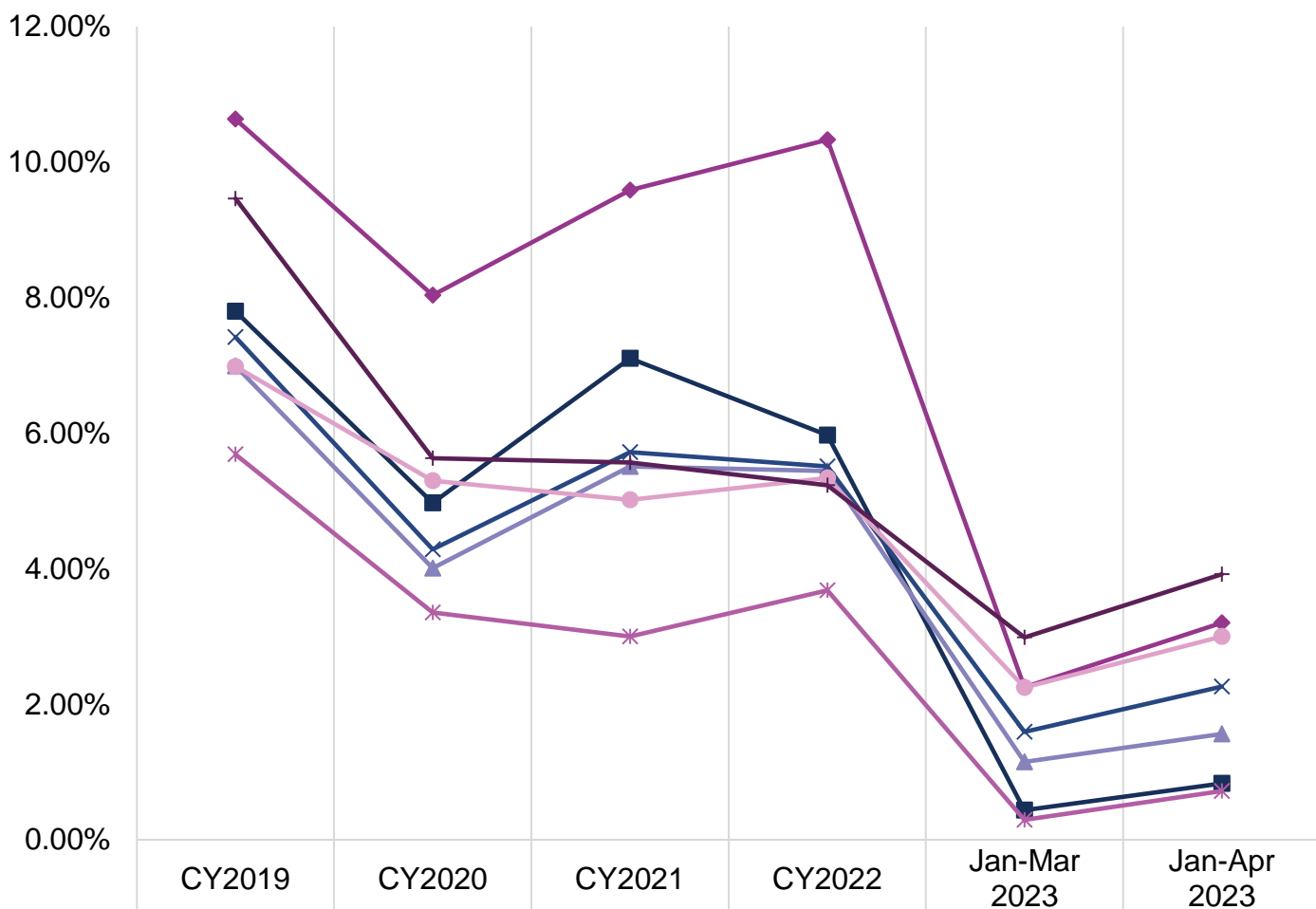

Sealant for Ages 10-14

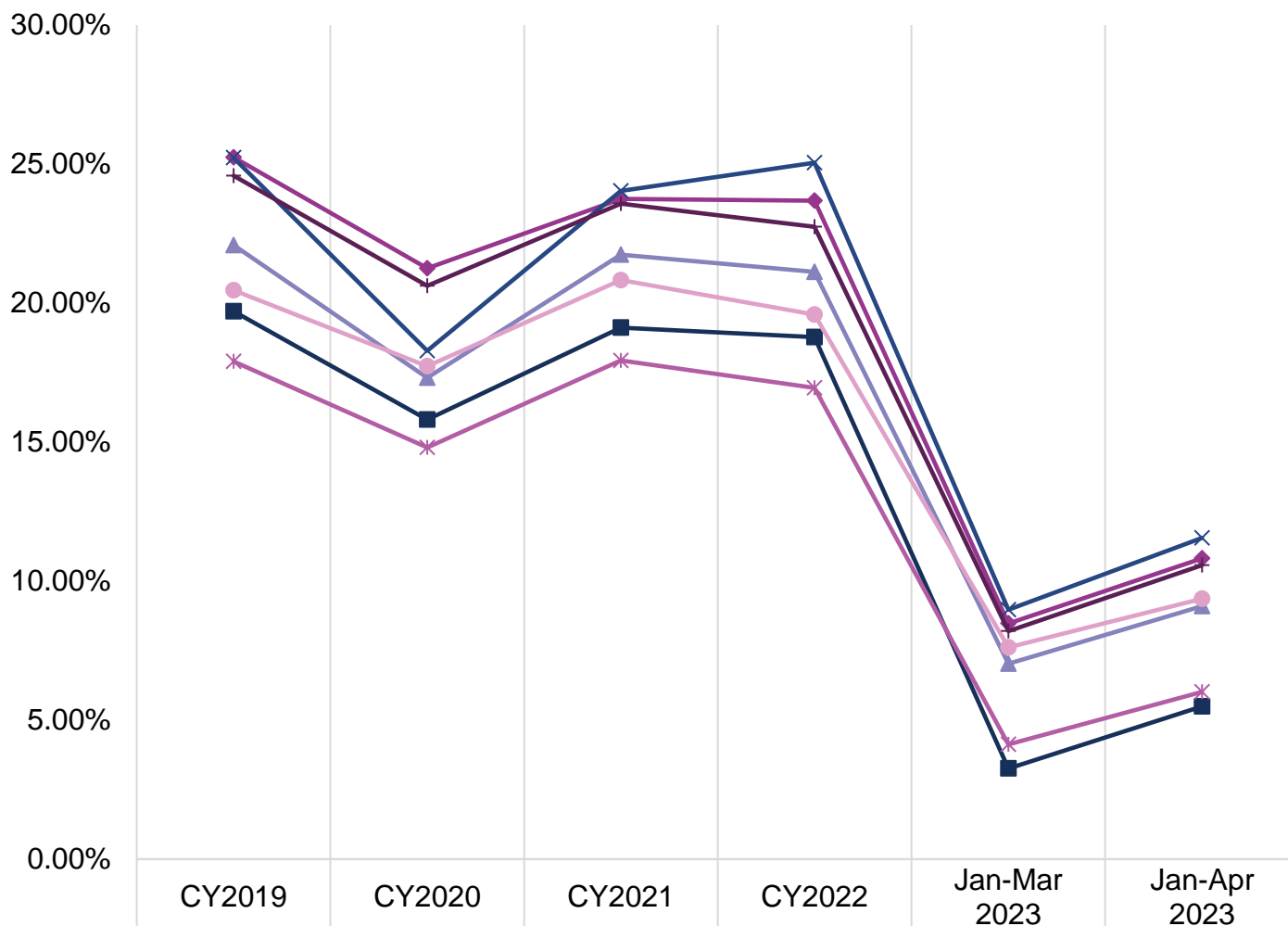

Dental Utilization in Adults Ages 21+

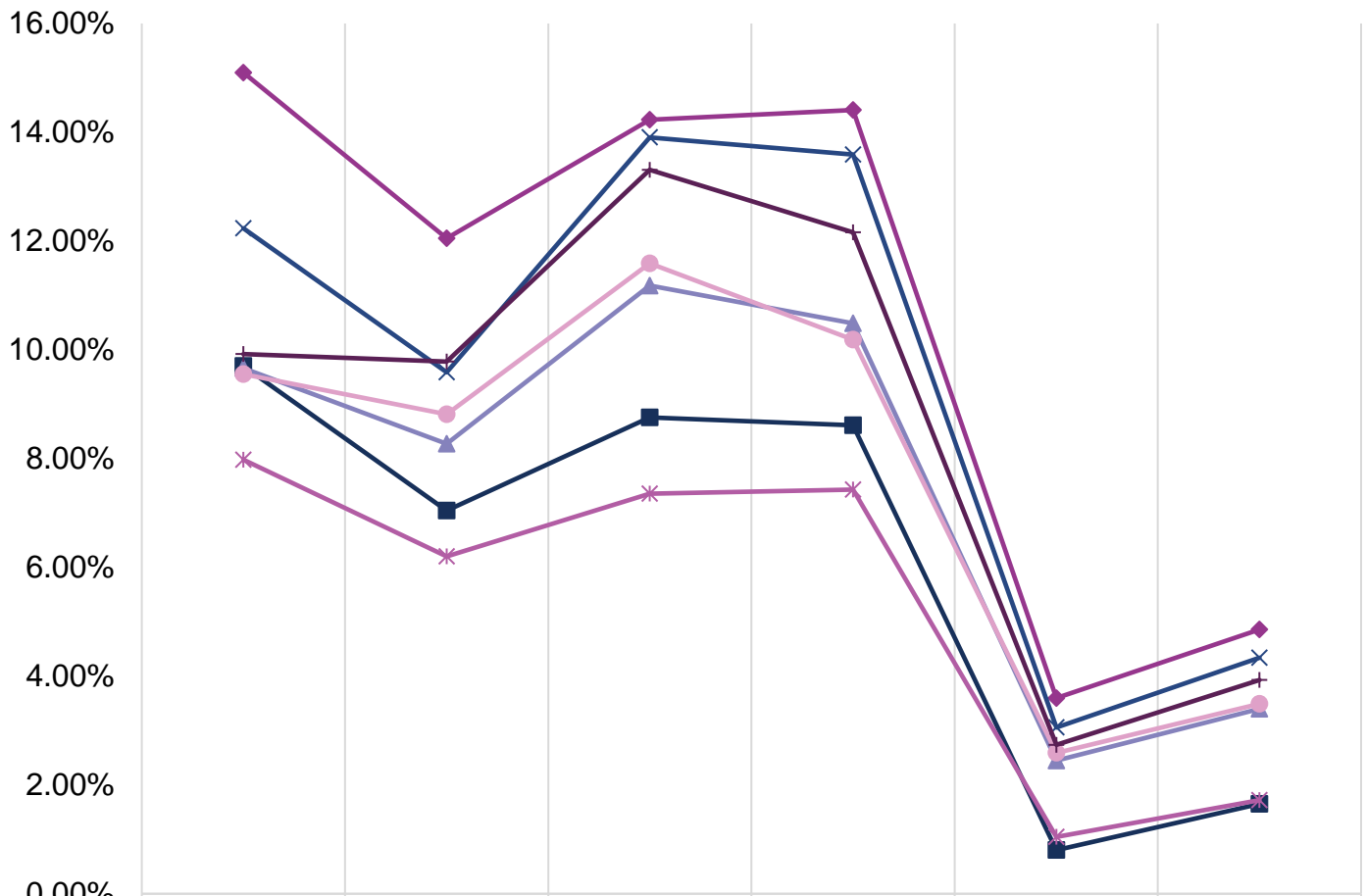

Data Source: Count of providers enrolled in April 2023 who also provided services within the last year in dental offices or SNCs within Los Angeles, Sacramento, and surrounding counties (Orange, Riverside, San Bernardino, Ventura, Yolo, Placer, and El Dorado). FFS provider counts provided by the Administrative Services Organization (ASO) and Provider Application and Validation for Enrollment (PAVE); DMC provider counts provided by DMC plans. Providers are matched with claims for dates of services between May 1, 2022, and April 30, 2023, as of June 16, 2023, to identify the county the providers served.
