
### **DENTAL UTILIZATION IN CHILDREN**




Figure 3: Sealants for Members ages 6-9




Figure 4: Sealants for Members ages 10-14



# Annual Dental Visits CY 2019 - March 2024 Utilization For Eligibles Ages 21+






