QIP POLICY LETTER 25-007

TO: ALL MEDI-CAL MANAGED CARE HEALTH PLANS
ALL QIP ENTITIES

SUBJECT: APPROVED COMMUNITY PARTNERSHIPS FOR CALENDAR YEAR
(CY) 2025

PURPOSE:

This QIP Policy Letter (QPL) informs QIP DMPH entities and Medi-Cal managed care health plans (MCPs) of community partnerships approved by DHCS for CY 2025. It also provides procedures for DMPHs on how to apply for modifications to the approved applications and instructions for future application submissions for entities wishing to include community partner data in subsequent QIP Calendar Years.

POLICY:

The participating QIP DMPH entities listed in Attachment 1, *Approved DMPH CY2025 Community Partners*, have been approved by DHCS to include contracted community partner data on selected measures in their QIP data submissions for CY2025. For additional details on the DMPH Community Partner policies, refer to the QIP CY2025 Program Policies and [QPL 24-010](#). For an overview of QIP data sharing responsibilities for MCPs (which includes community partner data), refer to [QPL 22-005](#).

Modifications

If a DMPH experiences a change affecting its approved application, the DMPH must notify DHCS within ten business days. DHCS will review modifications on a case-by-case basis. All applications, notifications, and modification requests should be submitted to the DMPH's QIP liaison.

Future Applicants

For future submissions, an updated CY application template will be emailed from the QIP mailbox and available on [eQIP](#). DHCS must receive new applications no later than 60 calendar days after the release of the applicable QIP CY Reporting Manual.
