How to Qualify for Hearing Aid Coverage

The Hearing Aid Coverage for Children Program (HACCP) is available to children and youth under age 21 who live in California and:

- Do not have health insurance
- Are not eligible for Medi-Cal or hearing aid coverage through California Children's Services (CCS)
- Have health insurance that does not cover hearing aids, or

- Have health insurance that only covers up to \$1,500 for hearing aids.

Please include a copy of these documents with your application:

- **1.** A provider referral for hearing aids/evaluation, or a hearing aid prescription
- 2. Proof of income eligibility (see chart to the right)
- **3.** Proof that you do not have hearing aid coverage, or that your health insurance only covers up to \$1,500 toward the cost of hearing aids.

HACCP covers:

- Hearing aids,	- Hearing aid supplies/accessories
- Hearing aid replacement	(including ear molds),
(including externally worn	- Hearing aid-related audiology services,
bone conduction hearing devices),	- Other related post-evaluation services

>>> Families can apply for HACCP and CCS at the same time.

>> Children can qualify for HACCP regardless of immigration status.




