ITEM 1 Approve January 2023 Meeting Minutes

Public Comment

Theresa Comstock requested an edit to her comment from the January 2023 meeting to clarify that she was encouraging the full Council to focus on adult residential facilities, rather than just the Housing and Homelessness Committee.

Lorraine Zeller, Community Living Coalition, Santa Clara County shared the need for advocacy for adult residential facilities.

ITEM 2 Chair-Elect Nomination

Barbara Mitchell made a motion to nominate Angelina Woodberry as the committee's Chair-Elect. The motion was seconded by Darlene Prettyman and passed with no abstentions. Angelina will be contacted to confirm she will accept the nomination as she was not present for this meeting.

ITEM 3

Workgroup Discussion

Jenny Bayardo provided an overview of the Council's workgroups and discussed how to best incorporate and collaborate the efforts between the committees and the workgroups.

Quarterly Meeting Workgroup Schedules:

- Children and Youth: Wednesdays, 10:30 am to 12:15 pm
- Substance Use Disorder: Thursdays, 12:15 pm to 1:15 pm
- Reducing Disparities: Thursdays, 12:15 pm to 1:15 pm

Jenny acknowledged that Vera Calloway and Barbara Mitchell attend the Reducing Disparities workgroup and Monica Caffey attends the Children and Youth workgroup. Barbara expressed willingness to switch to the SUD workgroup due to her interest in how Housing First interacts with substance use issues and with keeping people housed. Jenny suggested the committee designate time on the agenda moving forward to have these members provide an update on the activities of the workgroups. The Committee agreed.

Public Comment

Janet Frank, California Commission on Aging, recommended the Council establish an older adult committee. She also suggested having a standing agenda item to focus on older adult issues, as they are underserved and the fastest-growing homeless population.

ITEM 4

California's Housing Future 2040: The Next Regional Housing Needs Assessment

Marissa Prasse, Senior Housing Policy Specialist for Housing Policy Development Division for Housing and Community Development (HCD) presented an overview of the Regional Housing Needs Allocation (RHNA) process and their stakeholder initiative to acquire feedback. The RHNA process refers to the first two steps, determination, and allocation, in a multi-step process for how California plans for housing needs in each region of the state.

Marissa highlighted that the statutory objectives of the RHNA process are to:

- Increase housing supply and mix of housing types, tenure, and affordability in an equitable manner.

- Promote infill development and socioeconomic equity, protect environmental and agricultural resources, encourage efficient development patterns, and achieve the region's greenhouse gas reduction targets provided by the State Air Resources Board.
- Promote improved intraregional jobs-housing relationships, including jobs-housing fit.
- Balance disproportionate household income distributions (more lower-income RHNA to higher income areas)
- Affirmatively furthering fair housing (AFFH)

The RHNA Stakeholder Engagement Plan includes:

- March – May 2023: Stakeholder engagement period
- July 1, 2023: HCD progress update to the Legislature
- December 21, 2023: Final Recommendation Report due to the Legislature

ITEM 5 California Interagency Council on Homelessness Presentation

Executive Officer, Meghan Marshall provided a brief overview of the California Interagency Council on Homelessness' (CA ICH) Action Plan report. The Action Plan is a comprehensive collection of the state's efforts toward preventing and ending homelessness in the fiscal year. The CA-ICH's Action Plan orients the state's efforts to drive purposeful, meaningful, and measurable progress toward preventing and ending homelessness in California. In March 2021, the CA ICH adopted the Action Plan for Preventing and Ending Homelessness, with the expectation that the plan would be updated every year to reflect current priorities. Meghan reported that the Action Plan is currently under revision and that there are two public input forums coming up. The forums will provide an overview of the CA ICH update process and an opportunity to offer feedback and suggestions for future revisions.

ITEM 6 California Environmental Quality Act Update

CBHPC staff provided an update to the committee on the recent California Environmental Quality Act (CEQA) hearings hosted by the Little Hoover Commission (Commission). The Commission is America's only permanent, independent citizens' commission working to improve state government. They are a nonpartisan oversight agency created in 1962 and its membership includes 13 Commissioners, appointed by

the Governor and legislative leaders. The Commission's mission is to investigate state operations and promote efficiency, economy, and improved service.

The Commission is exploring the debate around CEQA and examining CEQA's role in protecting the environment and providing public disclosure and evaluating the nature and extent of CEQA's impact on housing, land use, and other issues. The Commission is also exploring the present state of the CEQA process and considering whether changes to CEQA or the process may be needed, and how to best ensure those changes. Eva provided discussion points shared at the hearing as it relates to the development of housing such as the challenge of not being able to accurately analyze CEQA's effectiveness. The committee wishes to continue to follow the activity around the CEQA hearings and will consider how the committee can participate.

ITEM 7 Community Listening Session Debrief

Eva Smith provided a report and led the discussion on the outcomes of the committee's 'Listening Session on Housing' held on Tuesday, April 11, 2023, from 3:00 pm to 5:00 pm. The Listening Session event featured brief presentations including an overview of the housing models available in California and stories from individuals with lived experience navigating the behavioral health system and being unhoused. After the presentations, the Listening Session portion provided comprehensive time to hear from persons with lived experience to voice their housing needs and share the barriers they encounter trying to obtain housing.

Eva reviewed the information shared by consumers of the public behavioral health system and their housing struggles. The group engaged in discussion but made no decisions about the next steps.

ITEM 8 Work Plan Discussion

Committee members decided to have an in-between meeting to further discuss and refine the work plan goals as other agenda items went over time and there was not sufficient time to address this agenda item. Staff, Eva Smith will send out a doodle poll to committee members to schedule the meeting.

How This Agenda Item Relates to Council Mission

To review, evaluate and advocate for an accessible and effective behavioral health system.

The information provided is intended to assist members in identifying areas the Council can provide input on the policies, guidelines, and regulations currently in development to reduce homelessness and ensure access to adequate housing and supports.

Background/Information:

CA Interagency Council on Homelessness (Cal ICH): The Cal ICH was created by **SB 1380** in 2017 as the Homeless Coordinating and Financing Council to oversee the implementation of **Housing First** policies, guidelines, and regulations to reduce the prevalence and duration of homelessness in California.

In 2021, Governor Newsom signed **AB 1220** into law, which renamed and restructured this Council to continue California's forward momentum toward the state's broader vision for greater statewide leadership and coordination around its response to the homelessness crisis. The mission of Cal ICH is to develop policies and identify resources, benefits, and services to prevent and work toward ending homelessness in California.

Council staff have been involved with Cal ICH through participation in their quarterly meetings and tracking their projects and activities. Cal ICH recently updated its 'Action Plan' to address the homeless crisis.

Through the Action Plan, Cal ICH pursues a vision for their Council and the state's work to prevent and end homelessness focused on purposeful, action-oriented coordination and alignment among state departments. The Plan was developed through input and collaboration with over 60 community entities, public agencies, nonprofits, and other experts. It is through this input that the 5 action areas and the goals were developed. The Action Plan orients the state's efforts to drive purposeful, meaningful, and

measurable progress toward preventing and ending homelessness in California, motivated by a vision of a future in which homelessness in California is: rare, because it is prevented whenever possible; brief, ended quickly whenever it does occur, through a focus on Housing First approaches and housing outcomes; and a one-time experience, ended successfully the first time, so that no Californians experience homelessness repeatedly.

In March 2021, the Cal ICH adopted the Action Plan for Preventing and Ending Homelessness, with the expectation that the plan would be updated every year to reflect current priorities. In September 2022, they adopted an updated Action Plan for Preventing and Ending Homelessness. The staff develops a progress report each year. The report is a comprehensive collection of the state's efforts toward preventing and ending homelessness in the fiscal year. Cody Zeger, Director of Statewide Policy for CA ICH, will present on their organization's Action Plan, their annual progress report and other recent developments.

About the Presenter:

Cody Zeger is the Director of Statewide Policy for the California Interagency Council on Homelessness. Prior to joining Cal ICH, he received a Master of Public Policy degree from UC Berkeley where he focused on analyzing and improving public programs related to homelessness and housing. Additionally, he has years of experience conducting data analysis and overseeing program implementation in both public agencies and nonprofit organizations on these issues.

At Berkeley, Cody completed projects such as an evaluation of Alameda County's Project Roomkey program, a literature review of effective anti-displacement policies, and a proposal for an innovative affordable housing development in Santa Fe, NM. In his prior professional work, he helped implement the San Francisco Chronic Homelessness Initiative, where he oversaw the initiative's \$100 million budget, managed a new housing subsidy program, and collected and analyzed program outcome data, among other responsibilities. He has also spent years volunteering with the San Francisco AIDS Foundation's Syringe Access & Disposal program.

Cody firmly believes that we can end homelessness as we know it today. With the right resources and a commitment to uplift the expertise of those who have experienced homelessness, he knows we can provide everyone with a safe, accessible, and affordable place to live.

This agenda item provides the committee the opportunity to be informed on an advocacy organization for owners and operators of Adult Residential Facilities (ARFs) and Residential Care Facilities for the Elderly (RCFEs) with residents who are reliant on public benefits and/or living with serious mental illness.

Background/Information:

Licensed Adult Residential Care Association (LARCA) is a new, nonprofit membership association for Los Angeles County-based owners and operators of Adult Residential Facilities and Residential Care Facilities for the Elderly, formed with fiscal sponsorship from the National Alliance on Mental Illness Greater Los Angeles Chapter (NAMI GLAC) and financial support from the Los Angeles County Department of Mental Health. The process of establishing the Association commenced in August 2021, with a goal to develop LARCA into a fully-independent, nonprofit entity within two years.

With an emphasis on serving the population of owners and operators of Adult Residential Facilities (ARFs) and Residential Care Facilities for the Elderly (RCFEs) with residents who are reliant on public benefits and/or living with serious mental illness, LARCA will advocate to enhance the capability and sustainability of all facilities to continue to fill a critical need in our Los Angeles County continuum of services for many of those who are otherwise at serious risk of experiencing homelessness. Bennie Tinson, Executive Director for LARCA will present to the committee on their organization's recent efforts to secure funding for ARFs and RCFEs.

About the Presenter:

In a career spanning over 20 years, Bennie Tinson is an accomplished non-profit leader, strategic organizer, government affairs and public policy professional. Bennie serves as the Inaugural Executive Director of the Licensed Adult Residential Care Association. He is the voice for 230 state licensed Adult Residential Facilities and Residential Care Facilities for the Elderly in Los Angeles County that provide housing and care for low-income residents living with Serious Mental Illness. Bennie Tinson is a former Regional Manager, Government Affairs & Organizing for the Service Employees International Union. Regional Director for Educators for Excellence where he advocated for classroom teachers in Los Angeles, New York & Boston; and a Lead Organizer with LA Voice and the Faith in Action Network. He earlier served as Director of Community Engagement at the California Charter School Association, Associate Faculty at Mount San Jacinto Community College District, and Government Affairs Officer at Altura Credit Union where he advocated on behalf of California Credit Unions.

Bennie earned a Master's degree in Public Policy at Pepperdine University, and a Bachelor of Arts degree in Political Science from St. Olaf College. He also studied abroad at Oxford University - Harris Manchester College in Oxford, England. Bennie is currently pursuing a Ph.D. in Political Science and Religion at Claremont Graduate University. In 2010, Bennie Tinson received the Woody Fleming & Willie (Motto) Robinson Award from the California Friends of the African American Legislative Caucus.
