#### **Item #1      Review and Discuss Recommendations for CA Behavioral Health Community-Based Continuum (CalBH-CBC) Demonstration Concept Paper**

The Systems and Medicaid Committee (SMC) staff highlighted that the CalBH-CBC concept paper is a means to develop the Medicaid Section 1115 Demonstration Waiver that the Department of Health Care Services (DHCS) will submit an application for to the Centers for Medicare and Medicaid Services (CMS) in 2023.
