I. Welcome and Meeting Information Sarah Brooks, DHCS Consultant with Sellers Dorsey

II. Roll Call Sarah Brooks

Conducted roll call of CCS Redesign Performance Measure Quality Subcommittee members, DHCS staff, and the Sellers Dorsey team

Summary Discussion:

- Members asked if a family representative could be added to the Subcommittee
 - Response: DHCS will work with Subcommittee member Tamica Foots-Rachal on identifying a family representative to add to the Subcommittee
- Members asked if county staff that provide direct services are included in the Subcommittee
 - Response: DHCS responded that public health nurses, Medical Therapy Program (MTP) representatives, and Neonatal Intensive Care Unit (NICU) staff are included on the Subcommittee

III. Background and Authorizing Statute Sabrina Atoyebi, Chief Medical Operations Branch

Provided overview of the 2018 CCS Performance Measure Quality Subcommittee and Welfare & Institutions Code (WIC) Section 14094.7(b)

Summary Discussion:

 Members asked for confirmation on when Assembly Bill (AB) 118 requires measures be implemented by CCS Redesign Performance Measure Quality Subcommittee – Meeting Summary August 17, 2023

- Response: DHCS confirmed that data collection for identified measures will begin by January 1, 2025
- Members mentioned in addition to the 2018 CCS Performance Measure Quality Subcommittee there was another technical workgroup in 2016/2017
 - o **Response:** DHCS acknowledges this comment
- Members requested 2018 CCS Performance Measure Quality
 Subcommittee recommendations be considered in forthcoming
 Subcommittee meetings
 - Response: Previous work efforts from the 2018 CCS Performance Measure Quality Subcommittee will be considered in the Subcommittee process

IV. CCS Redesign Performance Measure Quality Subcommittee Charter Olivia Thomas, CCS Program Policy Analyst Medical Operations Branch

Reviewed the CCS Redesign Performance Measure Quality Subcommittee goals, ground rules, membership expectations, roles and responsibilities, and voting process

- Members inquired if primary care measures will be reviewed as part of the Subcommittee process
 - o **Response:** DHCS acknowledges this comment
- Members expressed that it is challenging to identify measures specifically focused on the CCS beneficiary population
 - Response: DHCS recognizes this challenge and expressed the needs for high quality and relevant data is essential when recommending measures

V. Previous CCS Performance Measure Efforts Dr. Jill Abramson, Associate Medical Director Chief, Specialty Services Policy Unit

Reviewed previous CCS performance measure efforts such as the 2018 CCS Performance Measure Quality Subcommittee and domains

Dr. Linette Scott, Chief Medical Information Officer Enterprise Data and Information Management Reviewed Core Set Measures, 2018 CCS Performance Measure Quality Subcommittee recommendations, and data availability and feasibility requirements for measure selection

Joseph Billingsley, Assistant Deputy Director Integrated Systems of Care

Provided background on Whole Child Model (WCM) and details on the WCM evaluation

- Members requested the Subcommittee only consider measures for CCS beneficiaries and not Child and Youth with Special Health Care Needs (CYSHCN)
 - Response: Subcommittee members and DHCS agree the Subcommittee will focus on CCS beneficiaries
- Members expressed that while primary care provider visit and depression screening measures are important for overall child well-being, these measures do not focus on the CCS program's performance
 - Response: DHCS acknowledges this comment
- Members expressed that CCS program data is available through Children's Medical Services (CMS) Net
 - o **Response:** DHCS acknowledges this comment
- Members highlighted the importance of utilizing data that is readily available and relevant to the CCS population
 - o **Response:** DHCS acknowledges this comment
- Members acknowledged that in the short term the Subcommittee may need to focus on administrative measures rather than outcome measures due to limited data availability
 - o **Response:** DHCS acknowledges this comment
