I am pleased to inform you that your request to renew the California Section 1915(c) Home and Community-Based Services Assisted Living Waiver (ALW) serving individuals 21 years of age and older with physical disabilities has been approved. The renewal has been assigned Control Number CA. 0431.R03.00 and is approved with an effective date of March 1, 2019.

This five-year renewal will provide the following services: assisted living services, including homemaker, home health aide and personal care, care coordination, residential habilitation, augmented personal care development and follow-up, and nursing facility transition care coordination.
