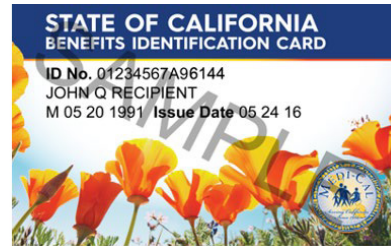
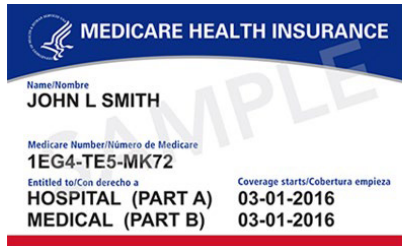

Thaum Lub Ib Hlis Tim 1, 2023, kev pab them nqi kho mob ntawm Medi-Cal nyob hauv ib cov nroog yuav hloov ntawm Fee-For-Service (FFS) Medi-Cal mus rau Medi-Cal Managed Care. Peb yuav muab cov ntawv ceeb toom xa tawm rau thaum lub Kaum Ib Hlis tim 1 thiab Lub Kaum Ob Hlis tim 1, 2022. **Cov nyiaj uas Medicare muab rau koj thiab koj cov kws kho mob los sis cov chaw kho mob yuav tsis.**

Rau cov neeg uas muaj Medicare thiab Medi-Cal tib si, kev pab them nqi kho mob ntawm Medi-Cal yuav hloov mus ua kev pab cuam Medi-Cal uas muaj tswj cov kev kho (Medi-Cal managed care) nyob hauv cov nroog uas tau muab teev tseg rau nram qab no. Medi-Cal ib qhov kev faj seeb yog ib qhov kev faj seeb rau kev kho uas saib xyuas tag nrho cov nyiaj los sis kev kho mob uas Medi-Cal muaj rau koj siv. Koj qhov kev faj seeb Medi-Cal yeej muab tau nyiaj los sis pub koj mus siv tau ib cov kev kho mob ntxiv nrog rau cov uas Medicare muab rau koj los sis pub koj siv tau. Cov nyiaj los sis kev kho ntawm no yog muaj:

- Kev saib xyuas Cov Kev Pab Cuam thiab Cov Kev Txhawb Nqa Mus sij Hawm Ntev (Long-Term Services and Supports) uas koj siv los yog xav tau
- Kev thauj mus thiab los ntawm cov kev teem caij mus kho mob
- Cov khoom kho mob tshwj xeeb thiab cov khoom siv coj los pab kom koj nyob tau nyab xeeb hauv koj lub tsev
- Txhim Kho Kev Tswj Hwm Kev Saib Xyuas Kho Mob (Enhanced Care Management) thiab Cov Kev Pab Txhawb Nqa Hauv Zej Zog (Community Supports) coj los pab kom koj nyob tau nyab xeeb hauv koj lub tsev
