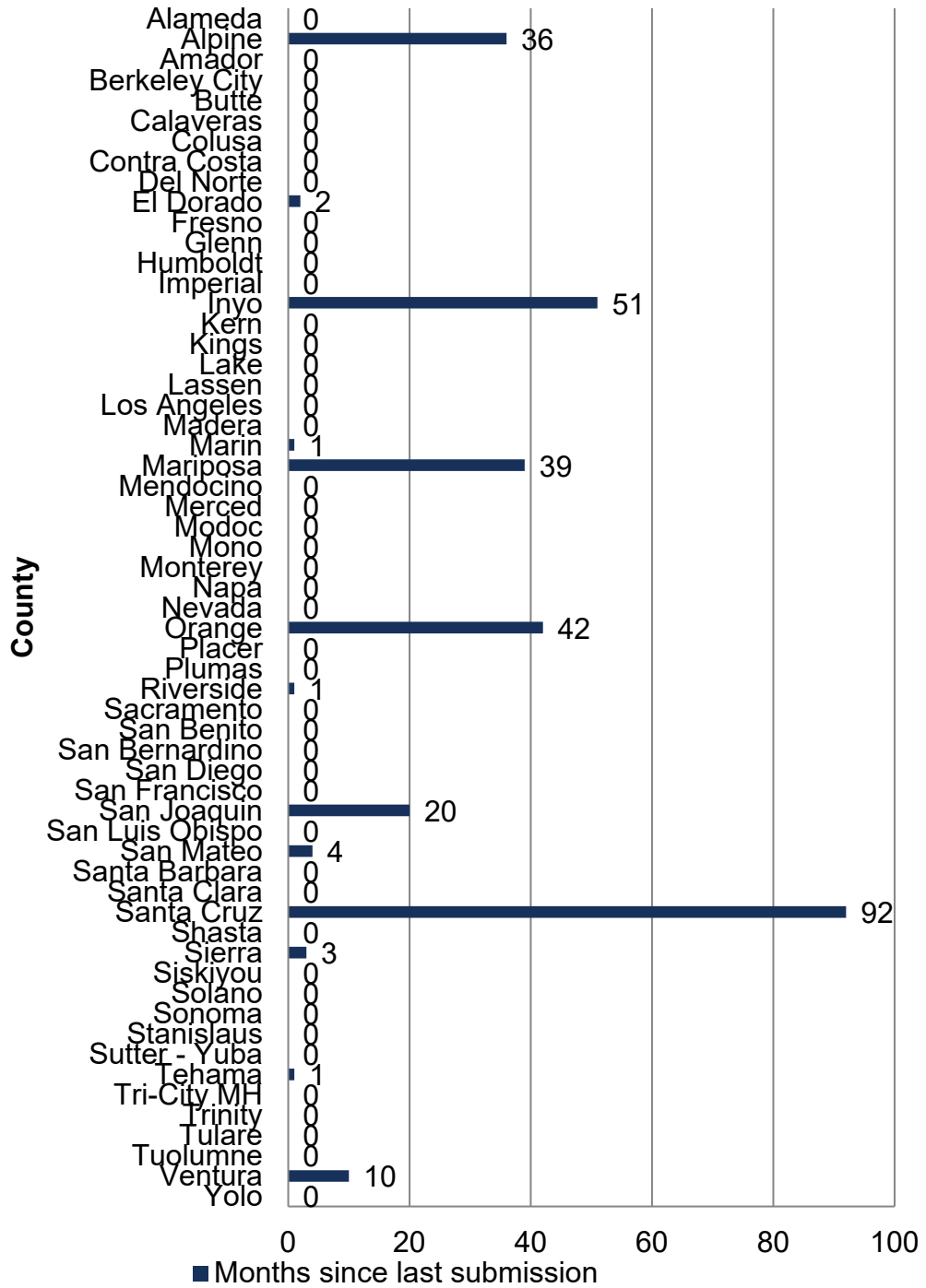

County	CA Department of Health Care Services Data Collection Reporting (DCR) System County Submission Issue Status as of 5/3/2025	Planned Submission Date
Alpine	County has not admitted clients to FSP since 2022 but is now admitting clients currently. County has a new Deputy Director and did not have the staffing to meet the service requirements for FSP clients such as access to 24/7 case managers or assistance with housing, nor did they have clients who wanted FSP services when they were offered. County requested access to BHIS portal and was given resources on how to begin submitting data.	County is working on getting clients in the portal this week.
Inyo	County's DCR coordinator has been out on leave. They were given resources on how to begin submitting their FSP DCR data.	No submission date was specified by county in their response.
Mariposa	County has been working on this. They have fixed the file according to the updated specifications however it is not being accepted on the state site. All FSP information is captured, and they have it prepared for upload once the state system will accept it.	They are waiting for final approval to move forward with submission.
Orange	County has been working with a few of their FSP providers on their XML exports (which is individual sets of XML files for each of our contracted providers rather than one PAF, one KET and one 3M XML for all of Orange County). They are also continuing to work on the clean-up of their DCR data, so note that the XML files they will submit beginning in January will	DHCS last reached out to Orange County regarding their DCR report on 5/8.

San Joaquin	County had a meeting with their EHR vendor and volunteered to enter their DCR pilot program with the hopes that this would expedite their ability to push DCR forms through to the state. They are working on efforts to prevent any possibility of duplicate entry as they are also entering some data forms directly into the State's website.	County's vendor is anticipating early August for the data push.
San Mateo	County has been working with DCR support staff for a few months to batch upload some missing data. They are currently awaiting approval from the DHCS CSD BData team and they anticipate that will be the final step after meeting all the requirements for submitting XML files.	N/A
Santa Cruz	DHCS sent a notice to the county on 6/4/25 but the county has not responded.	N/A
Ventura	County is currently having issues with access for the employees they have designated to do that data entry directly into the State Website, which is causing the delay. The staff seem to have access to the DCR application but do not see any of the data. They have been trying to troubleshoot this access issue. Their EHR vendor continually	County anticipates submitting data soon but did not give an exact plan for submission date.
