Topic: Immigrants denied Medi-Cal benefits may still be eligible for them.

If you are an immigrant who was denied or discontinued from Medi-Cal only because you had a border crossing card or short-term visa, you may be eligible to get Medi-Cal again. You can have your eligibility reviewed. For more information, contact your county welfare department.

:30

If you are an immigrant who was denied or discontinued from Medi-Cal only because you had a border crossing card or short-term visa, you may be eligible to get Medi-Cal again. You may have already received a letter explaining this policy. You have until December 31, 2000 to request a review of your eligibility. For more information, contact your county welfare department.

STATE HEALTH DEPARTMENT ANNOUNCES IMMIGRANTS DENIED MEDI-CAL MAY BE ELIGIBLE FOR REINSTATEMENT

SACRAMENTO - Immigrants who were denied or discontinued from Medi-Cal solely because they possessed a border crossing card or short-term visa may be eligible to get those benefits reinstated, the California Department of Health Services (DHS) announced today.

Under a policy that took effect in February 1997, some immigrants classified as aliens were denied or discontinued from Medi-Cal benefits solely because they possessed one of those documents. That policy was reversed in October 1998 as a result of a decision in a lawsuit filed in San Francisco County Superior Court by the Latino Coalition For A Healthy California against Kim Belshé, former DHS director.

Under the terms of the lawsuit, individuals who were denied or discontinued from Medi-Cal solely because they possessed a border crossing card or short-term visa can have their eligibility reviewed again. DHS is required, to the extent possible, to identify all individuals denied Medi-Cal benefits based solely on the application of former All County Welfare Director Letter No. 97-06 and to mail each identified person an individualized notice.

If found eligible, any Medi-Cal benefits that were denied or discontinued while the policy was in effect will be reinstated. Individuals who want to have their eligibility reviewed under the terms of this ruling have until December 31, 2000 to request a review by their respective counties.
