SUBJECT: ELIMINATION OF CPT CODE 92506; AND IMPLEMENTATION OF FOUR NEW REPLACEMENT CPT CODES 92521-92524; AND IMPLEMENTATION OF NEW AUDIOLOGY CPT CODE 92557

This Policy and Procedure Letter (PPL) notifies Local Educational Agencies (LEAs) participating in the LEA Medi-Cal Billing Option Program that current procedural terminology (CPT) code 92506, used to bill LEA initial/triennial, annual, and amended Speech-Language and Audiology Assessments, has been eliminated and replaced with four new, more specific evaluation codes.

Effective July 1, 2016, the LEA Medi-Cal Billing Option Program will eliminate CPT code 92506 (Evaluation of speech, language, voice, communication, and/or auditory processing), and implement the four new replacement CPT codes for speech-language assessments: 92521, 92522, 92523, and 92524. For dates of service before July 1, 2016, LEAs should continue to bill CPT code 92506 for speech-language and audiology assessment services.

The four new replacement CPT codes reflect smaller components of the original CPT code 92506, and are defined as follows:

- 92521 Evaluation of speech fluency (e.g., stuttering, cluttering)
- 92522* Evaluation of speech sound production (e.g., articulation, phonological process, apraxia, dysarthria)
- 92523* Evaluation of speech sound production (e.g., articulation, phonological process, apraxia, dysarthria) **with** evaluation of language comprehension and expression (e.g., receptive and expressive language)
- 92524 Behavioral and qualitative analysis of voice and resonance

*Note that CPT code 92522 is a sub-component of CPT code 92523, thus prohibiting LEAs from billing these two codes together for the same student.

Effective for dates of service on or after July 1, 2016, Speech-Language Assessments will use the new CPT code(s) 92521, 92522, 92523, 92524; LEAs should carefully review the CPT description to ensure they accurately bill for the service provided to Medi-Cal beneficiaries. In cases where multiple evaluations may be appropriate, documentation should clearly reflect a complete and distinct evaluation for each disorder.

Since the new replacement CPT codes do not cover audiological services, the LEA Program has selected a replacement code for Audiology Assessments. LEAs will use CPT code 92557 to bill for Audiological Assessments provided on or after July 1, 2016.

The LEA Medi-Cal Billing Option Program Provider Manual will be updated to reflect the current rates for these CPT codes.
