LEA BOP Reinvestment

- » Reference California *Education Code* 8804, which talks specifically about reinvestment of funds. *EC* §8804(g),
- » For purposes of this chapter, support services shall include case-managed health, mental health, social, and academic support services benefiting children and their families, and may include, **but are not limited to:**
 - (1) Health care, including:
 - (A) Immunizations.
 - (B) Vision and hearing testing and services.
 - (C) Dental services.
 - (D) Physical examinations, diagnostic, and referral services.
 - (E) Prenatal care.

LEA BOP Reinvestment (cont.)

- (2) Mental health services, including primary prevention, crisis intervention, assessments, and referrals, and training for teachers in the detection of mental health problems.
- (3) Substance abuse prevention and treatment services.
- (4) Family support and parenting education, including child abuse prevention and school-age parenting programs.
- (5) Academic support services, including tutoring, mentoring, employment, and community service internships, and in-service training for teachers and administrators. However, grants for these purposes shall supplement, not supplant, existing resources in these areas.

LEA BOP Reinvestment (cont.)

- (6) Counseling, including family counseling and suicide prevention.
- (7) Services and counseling for children who experience violence in their communities.
- (8) Nutrition services.
- (9) Youth development services, including tutoring, mentoring, recreation, career development, and job placement.
- (10) Case management services.
- (11) Provision of onsite Medi-Cal eligibility workers.

LEA BOP Reinvestment (cont.)

» The CDE does not approve or deny individual requests for allowable expenditures. If an LEA questions if an expenditure is a permissible use of funds, the CDE encourages LEAs to consult their agency's legal counsel. Below you will find a couple of resources regarding reinvestment of funds. (our partners at California School-Based Health Alliance. (2017-Enhancing-Services-for-Students-California-LEAs.pdf and California Code, EDC 8804.)

- » Are we allowed to utilize Medi-Cal funds to pay for a contractor or contracted services such as contracting an individual to conduct assessments, etc.?
- » Answer: Yes, this is an allowable use of reinvestment of funds.
- » May LEAs use LEA BOP reimbursements to send their admin assistant to the National Alliance for Medicaid in Education conference. Would this be an appropriate use of funds? The admin oversees the LEA BOP program for the district and would be using the knowledge she gains at the conference to better support the LEA with the running of their LEA BOP program.
- » Answer: Yes, this is an allowable use of reinvestment of funds.

- » A District who is having trouble finding special education teachers to hire. They are wondering if they can use their LEA Medi-Cal Reimbursements to help pay for a third-party company to assist them in finding sped teachers. Would they be able to use LEA BOP monies for this since the need to hire sped teachers is what would allow for students to be served and IEPs to be held.
- » Answer: Yes, this is an allowable use of reinvestment of funds.
- » Are LEA BOP funds able to be reinvested into transportation fees and transportation support for students and families?
- » Answer: Yes, this is an allowable use of reinvestment of funds.

- » Our District wants to purchase batteries for our golf carts. These carts are used, in part, to transport ill or injured students and are vital to the workings of the school sites. There are no funds budgeted for this purpose. Each battery is approximately \$2,700. School sites are struggling to find the money needed to keep the carts running. Would this be considered an appropriate use of funds from DHCS' perspective?
- » Answer: No, this is not an allowable use of reinvestment of funds.
- » Can Medi-Cal dollars be used to purchase student reinforcers of 10-dollar coffee gift cards?
- » Answer: No, this is not an allowable use of reinvestment of funds; this would be considered a gift of public funds.

- » Are any policies against reinvesting our funds into our Athletic Training supplies? We would like to spend our reimbursement funds on supplies that our athletic trainer uses to prep/treat students such as bandages, tape, ice packs, flex wrap etc.
- » Answer: No, this is not an allowable use of reinvestment of funds.
- » A teacher is requesting Medi-Cal reinvestment funds for a student who needs orthodontic surgery for severe overbite. The parent asserts this dental procedure will have a direct impact on his intelligibility and progress in speech. Is this something we can spend these funds on? If not, can you please provide an explanation I can give to the parents?
- » Answer: No, this is not an allowable use of reinvestment of funds.

- » May a District use their LEA BOP reinvestment funds to purchase comfort cubs for their students attending a wellness workshop for social and emotional help. Being that they can take the cubs home after the workshop is done, would that be considered a "Gift of Public Funds"?
- » Answer: No, this is not an allowable use of reinvestment of funds. This would be considered a gift of public funds. If the comfort clubs were to stay on a school campus, then it would be an allowable use of reinvestment of funds.
- » Can an LEA use LEA BOP funds to support one of their charters even though they do not bill as a consortium for LEA BOP? The charter does not participate in LEA BOP.
- » Answer: No, this is not an allowable use of reinvestment of funds. The CDE encourages LEAs to consult their agency's legal counsel.

- » If District Speech Language Pathologists (SLP) and SLP Assistants are billing for Medi-Cal, what percentage of the total funds collected by the district can be allocated to the SLP department?
- » Answer: This is an individual decision at the District level on how they allocate funds, there is no *EC* about percentages.

- » We have a LEA BOP program manager whose job is 100% dedicated to the operation of the LEA BOP program. We would like to be able to fund 100% of her salary through the Medi-Cal reimbursements received. If not 100%, is there a maximum percentage allowable? Is that an acceptable use of funds?
- » Answer: Yes, this is an allowable use of reinvestment of funds, but please note, this would be a District level decision as the funds are not guaranteed to be the same amount on a regular basis AND the District would have to be in agreement that if there were not funds available, it would be covered through general funds.

- » Our District would like to purchase a van with a wheelchair lift to transport Severely Handicapped students to and from various programs throughout the county, such as Workability. We would like to use LEA BOP funds to purchase this van, as the purchase of this van will directly benefit students.
- » Answer: Yes, this is an allowable use of reinvestment of funds, but please note, this would be a District-level decision, and we would encourage to consult with your District to ensure alignment with LCAP.

- » Can I hire someone to do Academic Support Services, Nutrition Services, Dental Services and Mental Health Services and pay them out of the reinvestment funds? I am looking to add SUPPLEMENTAL services, not SUPPLANT the payment of existing services.
- » Answer: Academic Support, Nutrition and Mental Health Services are allowable uses of reinvestment of funds, this would be a District level decision and CDE would encourage to consult with your District to ensure alignment with LCAP. CDE is not familiar with providing Dental Services, so CDE would not be able to provide guidance.

- » Can we look to our SELPA to provide student specific items for services like occupational therapy or should the LEA provide those? We have used our LEA funds in the past, but we are wanting to explore other options to share the financial obligation.
- » Answer: There is not EC around the determination of whether an item/service should be funded by the LEA or the SELPA. It is recommended to work with your SELPA and legal counsel for guidance.

- » We screen and nominate grant applications that are then reviewed by our Superintendent and administrators. Is there any additional guidance on the types of supplies/materials that can be purchased with grant funds (beyond what is in EC 8804)? Our Collaborative group is disagreeing on whether or not items such as t-shirts and prizes for groups or clubs funded by grants, food, and furniture for school sites should be allowed to be requested in grant applications. Some in our Collaborative argue that since these items become the property of the student or family and are taken off the LEA's property, these items cannot be funded by reinvestment funds.
- » Answer: CDE would need to know more information about the grants as there is specific language used in the usage of funds. In general, if these funds are LEA BOP reinvestment of funds, prizes, food or t shirts would not be an allowable use of funds. I will defer to your legal counsel for guidance.



- » <u>LEA BOP</u> The formation of an LEA Collaborative is a state mandate outlined in the Provider Participation Agreement (PPA). This group must represent a diversity of stakeholders that votes on the reinvestment funds within school-linked support services (supplement not supplant).
- » LEA Collaborative Guidelines have been established to provide a structure of the process of the grant proposals, meetings and reinvestments.
- » Grant proposals are reviewed for approval by Collaborative Board members during LEA Collaborative meetings.

Grant Request

- » Reinvestments>Up to 15% of total reimbursement amount (off the top) for the LEA BOP Administration / Operations: Medi-Cal Programs Staff
 - Manager
 - Oversees billing operations for all LAUSD reimbursement programs
 - Medical Billers X4
 - Create, submit and reconcile claims and reimbursement for all LAUSD reimbursement programs
 - Quality review of service documentation for all reimbursement programs
 - Medi-Cal Advisors X4
 - 50% of their salaries
 - Provide quality review of LEA claims

Reimbursement Responsibilities

Distribution of LEA BOP Reimbursements

» Weekly

Cost to participate in LEA BOP Consortium

How do we cover the cost to be a Lead LEA?

» CRCS & Prior Year Adjustments

> Prior year adjustments are made based on provider, if known, when not known, the adjustments are shared as a % of total claims each LEA earned

 CRCS settlements are either held as a withhold or paid at the LEA's % of claims for the originating year of service

- » Third Party Billing Vendor
 - Billing vendor costs are shared by a % of total reimbursement for all LEAs
- » Lead LEA Staff
 - Staff full-time equivalent (FTE) costs are determined based on the percent of time each staff member is dedicated to LEA BOP
 - FTE, costs are then shared amongst all consortium members as a % of total claims each LEA earned
 - Costs to LEAs are much lower than if any LEA participated on an individual basis and paid a staff member to manage LEA BOP

- » MER & Indirect Cost Rate
 - Weighted Average is used for all calculations.
 - All LEAs in consortium have similar rates therefore any rate variances are considered minimal to overall costs and reimbursements

Mendocino County Student Health Billing Consortium Philosophy

MCOE provides educational leadership, resources, and services to schools and districts to ensure a wide array of educational opportunities for all students.

It is the intention of Mendocino County Office of Education to assist LEAs to first, serve the student. We then look at billing opportunities for health services that LEAs are already providing to students. We develop and maintain billing systems that will capture supports and services that are eligible for reimbursement from all health insurers.

We strive to maintain a sustainable cost recovery system and work to expand service billing opportunities as the need is evident. We recognize that emerging billing systems need to be approached with a growth mindset and strive to provide strong structures that will allow utilization of all billing systems at a level that helps to support the needs of our partner LEAs while improving student outcomes.

LEA BOP Mental Health Services Overview



Current vs. Future State: Mental Health Services

- >> Currently, the California State Plan covers mental health assessments, screenings, and treatment services.
 - Individualized Education Plan (IEP)/Individualized Family Service Plan (IFSP) and general education populations.
 - Treatments must be authorized by a licensed practitioner and included in a care plan.
- In the next State Plan Amendment (SPA), DHCS hopes to enhance services, including mental health services by:
 - Expanding covered services
 - Expanding qualified practitioners
 - Removing participation barriers

Educationally-Related Mental Health Services (ERMHS)

- » Psychology and counseling services identified in an ERMHS assessment are covered services when they meet the following criteria:
 - 1. Student must be **enrolled in Medi-Cal** on the date of the service.
 - 2. Service is rendered by a LEA BOP **qualified practitioner**.
 - 3. Service is **medically necessary**.
 - 4. The service must be **authorized by an ORP** practitioner.
 - 5. Service must be **pursuant to a Care Plan**.
 - 6. Must meet all other LEA BOP program requirements.
 - 7. Service **cannot be fully funded** by another funding stream.
- Practitioners who meet LEA BOP qualified practitioner standards with ERMHS in their job title may be included in the RMTS through the TSP Equivalency process.

Authorization for Mental Health Services

Assessments

Assessment services may be recommended by **parents**, **teachers or practitioners within scope of practice**.

Authorizing Documentation:

- » Student information
- » Date, reason, and individual requesting assessment

Screenings

Screenings **do not** require a written or signed recommendation.

Authorizing Documentation:

- » Copy of the Bright Futures periodicity table recommending screening for students in LEA's central file.
- » State-mandated vision/hearing screening intervals.

Treatments

Psychological and Counseling treatment services must be recommended by a qualified, **licensed Ordering/ Referring/Prescribing (ORP) practitioner**.

Authorizing Documentation:

- » Student information
- Written ORP recommendation (signed / dated)

Note: Authorization is valid for one year from date of recommendation.

Appropriate and adequate documentation of services continues to be requirement for reimbursement from the LEA BOP.

Mental Health ORP Practitioners

- » Qualified mental health ORP practitioners:
 - Licensed psychologists
 - Licensed educational psychologists
 - Licensed clinical social workers
 - Licensed MFTs
 - Licensed physicians
 - Registered credentialed school nurses
- >> How to become a qualified ORP practitioner:
 - Register for an individual National Provider Identification (NPI) number.
 - Enroll in Medi-Cal as an ORP Provider in the Provider Application and Validation for Enrollment
 - (or PAVE) system.
- » LEAs may contract out review of student records by a physician to obtain an order, referral, or prescription.

Individualized Care Plans

>> To be a billable under LEA BOP, treatment services must be pursuant to a care plan.

IDEA Plan (IEPs/IFSPs)

- » Education management tool for providing educationally necessary services and supports for IDEA-eligible students.
- » May include health-related treatment services to support education goals.
- » Outlines a tailored plan of specialized instruction and services to meet the student's unique educational needs.

An Individualized Family Service Plan (IFSP) is the counterpart to an IEP for children ages 0-3.

Individualized Health & Support Plan (IHSP)

- » Medical management tool for providing medically necessary direct healthcare services to students.
- » Must include student's healthcare needs, required treatment plan / duration, etc.
- Students <u>do not</u> have to be IDEA-eligible to receive services under an IHSP.

Includes: Individualized School Healthcare Plan; Plan of Care; Treatment Plan; Nursing Plan, 504 Plan.

Supervision Requirements

- Associate Marriage and Family Therapists and Associate Clinical Social Workers must be supervised by one of the following practitioners who have held a license for at least two years:
 - Licensed clinical social worker
 - Licensed Marriage and Family Therapist (MFT)
 - Licensed professional clinical counselor
 - Licensed clinical psychologist
 - Licensed physician certified in psychiatry
- 2. Anyone without a Pupil Personnel Services Credential must be supervised in their school-based activities by an individual holding a PPS credential.
- 3. Physician Assistants must follow supervision / delegation requirements in accordance with their practice agreement.

Diagnosis Codes

- » A diagnosis code (ICD-10) is required on a Medi-Cal claim.
- When a diagnosis has yet to be established, Unspecified Z Codes may be used. For example:
 - Z55-Z65 "Persons with potential health hazards related to socioeconomic and psychosocial circumstances.
 - Z03.89 "Encounter for observation for other suspected diseases and conditions ruled out".

Parental Consent Requirements

- DEA Students. LEAs must get initial written parental consent to access public benefits and bill for services pursuant to an IEP/IFSP.
 - Parents must receive annual notification of the benefit after initial written consent has been provided.
 - Parents may revoke consent at any time.
- » Non-IDEA Students. Parental consent beyond applying for and receiving Medi-Cal benefits is not required for a student to receive or an LEA to *bill* for services.
 - However, to protect both minors and parents, CMS encourages LEAs to put a parental consent protocol in place for non-IDEA services to ensure adequate and standardized processes and steps are in place.

IMPORTANT! In all situations, LEAs should check with their school district legal counsel to ensure that they are in compliance with FERPA requirements, prior to submitting claims to Medi-Cal.

2025 SPA Submissions & Mental Health Services

- >> DHCS is currently drafting two SPA packages for submission in 2025:
 - 1. SPA 1 Package: Expansion/Clean-Up Language
 - 2. SPA 2 Package: Reimbursement Methodology SPA
- » SPA 1 Package proposes to enhance program services, including mental health services by:
 - Expanding Covered Services
 - Expanding Qualified Practitioners
 - Removing participation barriers
- » SPA 1 implementation expected to be effective retroactive to July 1, 2025.

SPA 1: Expanding Covered Services – Crisis Assessment

- » Expands psychology and counseling assessment services to include crisis assessment.
 - Recommended by a parent, teacher or practitioner within scope of practice.
 - New crisis assessment billing code and 15-minute rate.
- » No change to treatment services. Crisis intervention treatments will remain billable if pursuant to a care plan.

Associate Professional Clinical Counselors (APCCs)	 Psychology / Counseling TCM 	No, registered with the Board of Behavioral Sciences.	Yes, by a LPCC, Licensed Marriage and Family Therapist (LMFT), Licensed Clinical Social Worker, Licensed Psychologist, Licensed Educational Psychologist or Licensed Physician.

SPA 1: Removing Participation Barriers – College Billing

- » DHCS will propose that colleges be exempt from the Pupil Personnel Services (PPS) Credential supervision requirement for the following practitioners:
 - Licensed Clinical Social Workers
 - Licensed Educational Psychologists
 - Licensed Professional Clinical Counselors

- Licensed MFTs
- Licensed Psychologists

» Post-secondary LEAs will no longer be held to the PPS Credential supervision requirement, if approved by CMS.



Eligible Services	Expanded set of mental health and substance use disorder services <i>not</i> furnished pursuant to an IEP/IFSP.	Certain mental & physical health services for both special education and general education students.
Covered Students	Enrolled members of a health plan under 26, enrolled at participating LEAs and Institutions of Higher Education.	Medi-Cal eligible youth under 22 enrolled at participating LEAs.
Obligated MCPs, Health Care Plans, & Insurers	 Medi-Cal FFS Medi-Cal MCPs Health care service plans Disability insurers 	Medi-Cal FFSMedi-Cal MCPs
Reimbursement	Reimburses federal and state share through pre-determined FFS rates.	Reimburses federal share only through a cost settlement process (CRCS). Cost allocation based on RMTS and MER.

Billing for Mental Health Assessments

- » Annual, amended and triennial psychological and psychosocial status assessments are all billable to LEA BOP using the TL or TM modifier.
- Initial mental health assessments used to determine IDEA eligibility are billable to <u>either</u> CYBHI or LEA BOP.
 - If LEAs choose to bill initial assessments through LEA BOP, they will use the TL or TM modifier, consistent with past guidance.
 - If LEAs choose to bill initial assessments through CYBHI, total CYBHI payments will be deducted from the CRCS.
- » All mental health assessments that are not related to IDEA eligibility are only billable through the CYBHI fee schedule.

Avoiding Duplicate Payment

When LEAs participate in both programs, avoiding duplication is accomplished in two ways:

1) Claims Payment

Behavioral health claims will be paid based on whether the service is pursuant to an IEP/IFSP.

- LEA BOP will pay claims for all mental health services pursuant to IEP/IFSP.
- CYBHI fee schedule will pay claims for services not pursuant to an IEP/IFSP.

2) Cost Settlement

CYBHI fee schedule total payments <u>for</u> <u>practitioners with costs on the CRCS</u> will be deducted on the CRCS (by practitioner type):

 LEAs that participate in both programs will net out CYBHI payments from salary / benefit costs reported on the CRCS.

DHCS believes that participating in both the LEA BOP and CYBHI fee schedule will result in additional LEA funding.
