Los Angeles County has been selected to participate in a proposed three-year demonstration that aims to improve coordination of medical and social services for low-income seniors and people with disabilities who are dually eligible for Medicare and Medi-Cal.

Under the proposed demonstration, L.A. Care and Health Net would be responsible for delivering all Medicare and Medi-Cal benefits and services, including medical care, long-term care, and social supports that help dual eligible beneficiaries maintain their health and live at home as long as possible. Consistent with requirements set in state law, L.A. Care and Health Net provided evidence of a robust local stakeholder process and local support for developing an integrated care delivery system.

L.A. Care and Health Net submitted applications to offer a collaborative, two-plan model solution for dual eligibles throughout all of Los Angeles County. The two-plan model has operated in Los Angeles County for 15 years and provides a strong platform upon which to build a seamless, person-centered experience for dual eligible beneficiaries. L.A. Care and Health Net will build on their extensive Medi-Cal and Medicare networks and local stakeholder relationships to coordinate and streamline a full range of primary, acute, behavioral and long-term services and supports. Both health plans will work extensively with federal, state and local agencies to prepare for the demonstration and its launch date of January 2013.
