San Diego County has been selected to participate in a proposed three-year demonstration that aims to improve coordination of medical and social

services for low-income seniors and people with disabilities who are dually eligible for Medicare and Medi-Cal. Under the proposed demonstration, dual eligible beneficiaries in San Diego County would have a choice of enrolling in Care 1st, Community Health Group, Health Net or Molina health plans.

Under the proposed demonstration, these health plans would be responsible for delivering all Medicare and Medi-Cal benefits and services, including medical care, long-term care, and social supports that help dual eligible beneficiaries maintain their health and live at home as long as possible. Consistent with requirements set in state law, these health plans provided evidence of a robust local stakeholder process and local support for developing an integrated care delivery system.

San Diego County has had a long-standing commitment to developing an integrated care delivery system for seniors and persons with disabilities. For a dozen years, through the county's Health and Human Services Agency and Aging and Independence Services have partnered on the Long-Term Care Integration Project. The demonstrable collaboration between San Diego County and the selected health plans is a strong indicator that the proposed demonstration will succeed there in improving beneficiary health.
