From 12-1-05 through 2-1-06, 0% was allocated to Care First and the other plan's rates were proportionally higher. For Sacramento county Year 2, rates shown were in effect 12-1-06 through 10-1-07. For the month of 11-1-07, 0% was allocated to Care First and the other plan's rates were proportionally higher. For Fresno, Kings, and Madera county Year 6 and Year 7, the rates shown were in effect 3-1-11 through 10-1-11, at which time CalViva will received 60% and Anthem Blue Cross 40% in each of those counties. The Year 6 rates for Alameda and Santa Clara county have been revised due to the discovery of an error in the original calculation.

\*Until HEDIS measures are able to be determined, the Auto Assignment of defaults for the new rural counties will provide an equal share to each plan in each county, unless there is an administrative reason for a different distribution.
