RE: Change Memo: Second Round - Whole Person Care Pilot Application

Dear Ms. Brooks:

On behalf of the Whole Person Care (WPC) Collaborative here in Orange County, it is my pleasure to submit Orange County's Second Round application for the Whole Person Care Pilot Program in the amount of \$7.567 million over three and one half years, beginning July, 2017. If approved, this would bring Orange County's total WPC Pilot over the 5-year term to \$31.067 million.

This Second Round application further enhances the new infrastructure development and innovations targeted toward the needs of two beneficiary populations: 1) persons who are experiencing homelessness and 2) persons who are living with serious mental illness, with an emphasis on those that are experiencing homelessness. The collaboration of the various participating entities required to develop the proposed WPC Pilot for Orange County, resulting in this grant application, continues to generate a lot of excitement for improving care coordination and support for these vulnerable populations. The entities newly added to the WPC Collaborative as a result of this second round application are also excited about the opportunities this will bring.

Per the WPC Pilot Expansion Instructions, this also serves as Orange County's Change Memo.

Overview of Expansion Application Changes:

Orange County is requesting an additional \$1,080,980 for the second half of Program Year 2 and \$2,161,960 annually for Program Years 3 through 5 to provide the following expanded services:

- Increase the number of unduplicated beneficiaries served by 1,205.
- Incorporate the outreach, engagement, and supportive services provided in the drop-in and multi-service centers into the WPC to better link these beneficiaries to the WPC Participating entities reaching an additional 300 beneficiaries.
- Expand the number of Recuperative Care Bed days from 12,612 to 27,320 over the term of the WPC Pilot.

- Dedicate Recuperative Care Bed resources to clients identified in the Courtyard as having a high medical acuity
- Fund a nurse to review patients referred to Recuperative Care and approve/authorize the level of acuity
- Fund four additional community clinics to add homeless outreach and coordination services and link to the WPC care plans increasing the number of member months from 72,000 to 83,472 over the term of the WPC Pilot
- Provide the administrative infrastructure for a shared electronic Care Plan accessible to the WPC Participating Entities providing services to the WPC beneficiaries by funding the IT resources to program the interconnectivity between the WPC Care Coordination platform and the Managed Care Plan's Care Management System.
- Fund the administrative resources needed to implement, monitor and report on expanded WPC activities

Attached please find a table summarizing each substantive modification to Orange County's legacy application.
