Subject: Notice of Proposed Change to the Medi-Cal Program

The purpose of this letter is to provide information regarding a proposed change to the Department of Health Care Services' (DHCS) Medi-Cal Program that will be submitted to the Centers for Medicare and Medicaid Services (CMS). DHCS is forwarding this information for your review and comment.

DHCS is required to seek advice from designees of Indian Health Programs and Urban Indian Organizations on Medi-Cal matters having a direct effect on Indians, Indian Health Programs or Urban Indian Organizations per the American Recovery and Reinvestment Act of 2009 (ARRA). DHCS must solicit the advice of designees prior to submission to CMS of any State Plan Amendment (SPA), waiver requests or modifications, or proposals for demonstration projects in the Medi-Cal program.

Please see the enclosed summary for a detailed description of this DHCS proposal.

**Department of Health Care Services (DHCS)  
Tribal and Designees of Indian Health Programs Notice**

**PURPOSE**

To seek federal approval for the continuation of the existing Ground Emergency Medical Transport (GEMT) program, which assesses a Quality Assurance Fee (QAF) and provides increased payments for GEMT services, effective for dates of service from July 1, 2025 through June 30, 2026.

**BACKGROUND**

Senate Bill (SB) 523 (Chapter 773, Statutes of 2017) established a QAF program for GEMT services, effective July 1, 2018. Under this program, DHCS collects transport and revenue data from GEMT service providers. The data is used to determine: 1) an annual QAF and 2) an add-on amount that increases the Medi-Cal reimbursement amount for GEMT services.

GEMT providers will be charged a QAF on all ground emergency medical transports rendered, regardless of payer type, and billed with the following codes:

Table A: Eligible GEMT QAF Healthcare Common Procedure Coding System (HCPCS) Codes

A0429	Basic Life Support	\$220.80
A0427	Advanced Life Support, Level 1	\$220.80
A0433	Advanced Life Support, Level 2	\$220.80
A0434	Specialty Care Transport	\$220.80
A0225	Neonatal Emergency Transport	\$220.80

Contingent upon federal approval, GEMT providers will receive increased reimbursement through the application of an add-on to the Medi-Cal fee-for-service fee schedule amount for the above-listed service codes, effective for dates of service July 1, 2025 through June 30, 2026.

DHCS also submitted SPA 25-0002 to the Centers for Medicare and Medicaid Services (CMS) proposing to continue the Public Provider Ground Emergency Medical Transportation (PP-GEMT) Intergovernmental Transfer (IGT) Program, effective for dates of service January 1, 2025 to December 31, 2025. Pursuant to Assembly Bill (AB) 1705 (Chapter 544, Statutes of 2019) public providers eligible for the PP-GEMT IGT program are not eligible to participate in the GEMT QAF program. Public providers are no longer assessed the QAF prospectively and are not eligible to receive the add-on through the GEMT QAF program.

Proposed SPA 25-0003-A: The Ground Emergency Medical Transport Quality Assurance Fee (GEMT QAF) Program for Private Providers

## **SUMMARY OF PROPOSED CHANGES**

Continuation of current GEMT QAF Program for dates of service July 1, 2025 through June 30, 2026.

### **IMPACT TO TRIBAL HEALTH PROGRAMS (THPs)**

To the extent THPs are enrolled in Medi-Cal as a GEMT provider, they must submit the required data reports and QAF payments to DHCS by the due dates. Eligible GEMT private providers will receive the increased reimbursement QAF for eligible Medi-Cal GEMT services provided for dates of service July 1, 2025 through June 30, 2026.

### **IMPACT TO FEDERALLY QUALIFIED HEALTH CENTERS (FQHCs)**

DHCS does not anticipate an impact to FQHCs as a result of the GEMT QAF program.

### **IMPACT TO AMERICAN INDIAN MEDI-CAL MEMBERS**

DHCS does not anticipate an impact to American Indian Medi-Cal members who receive GEMT services.
