274 Behavioral Health Companion Guide V3.01

Overview

- » On January 27, 2025, DHCS released a new version of the 274 Behavioral Health Companion Guide (CG) V3.0 to become effective on May 1, 2025.
- » DHCS is pushing out the effective date by one month to June 1, 2025. This will allow additional time for plans to modify and test their systems.
- » An updated CG V3.01 was released today, March 24th, with the new effective.
- » A DHCS test environment will be available on May 1, 2025 and the Production environment will be deployed on June 1, 2025.
- » The CG V3.01 updates impact MHP, DMC-ODS and IBHPs.

Contract Effective Dates

- » The contract effective date must be equal to or less than the last day of the reporting month entered in ISA02. **Set Fatal Error**
- » The contract expiration date must be greater than contract effective date. **Set Fatal Error**
- » **If Contract Expiration Date is less than the first day of the reporting month, set Warning Message.**

Submission Process

- » MHP, DMC-ODS and IBHPs will continue to use **the same DHCS-PACES SFTP folders** that are currently in use.
- » For example, Orange County will continue to use the following folders for IBHP submissions:

Testing Process

- » **Preparation (Feb-April 2025):** MHPs, DMC-ODS, and IBHPs modify systems.
- » **County Testing (May 1-31 2025)**
 - DHCS deploys test environment on May 1, 2025 (DHCS-PACES/Test).
 - Plans must complete testing no later than May 31, 2025, and begin production submissions no later than June 10, 2025, for the May reporting period.
 - **DHCS will conduct quality checks on production files.**
 - Plans must continue submitting MHP and DMC-ODS data files through May 2025 using CG V2.1.
- » **Go-live (June 2025)**
 - Starting June 2025, plans must submit 274 transactions using V3.01.

274 BH CG V3.01 Deployment Timelines

January

- Draft CG V3.0 sent to counties 1/9/25. Comments due by 1/22/25.
- Final CG V3.0 sent to counties on 1/31/25.
- Counties continue MHP/DMC-ODS submissions using CG V2.1

Feb – April

- Counties modify systems 274 CG V3.01 sent on 3/24/25.
- DHCS modifies systems.
- Counties continue MHP/DMC-ODS submissions using CG V2.1.

May

- DHCS deploys Test Environment on May 1, 2025
- Counties submit test files (5/1-5/31/25)
- Counties continue MHP/DMC-ODS submissions using CG V2.1.

June

- DHCS deploy Production environment on 6/2/25)
- Counties submit no later than 6/10/25 for May reporting period using CG V3.01.
- DHCS sends quality check reports by end of May.

July

- Counties resubmit June files.
- Plans submit no later than 7/10/25 for June reporting period.
- DHCS release quality checks no later than 7/25/25.

- » The 274 BH VRF v1.3 is a custom XML error report DHCS PACES automatically generates in a County's **Response** folder.
- » These are available to download (viewable in excel as XML table or via notepad++ with XML Tools)

Counties download **VRF v1.3** to view:

- » **<ValidationStatus>**: File was "Accepted" or "Rejected"
- » If Rejected, see: **<Response Severity>="error">**
- » See examples in DHCS – Docs Center

New 274 BH VRF Replaces Provider Data Submission Reconciliation Form (PDSRF)

- » **Starting April 1, 2025**, counties are no longer required to submit the PDSRF **and** the VRF file to the 274 County SharePoint Site.
- » New VRF v1.4 includes PDSRF header counts – Streamlines county submissions and reduces number of files to format and submit.
- » Help counties catch critical errors earlier in submission the process.
- » **Beginning April 1, 2025** – Counties are expected to review the updated VRF v1.4 to ensure accuracy of
 - Reporting Year and Month
 - Distinct Group Count using Group Tax ID
 - Distinct Site Count using Site NPI
 - Distinct Provider Count using Provider NPI

Planning for the BH VRF v1.4 Updates

- » **DHCS PACES Test Environment Effective March 1, 2025.** Starting on and after 3/1/25, test transactions submitted to the DHCS-PACES/Test folder will receive the updated VRF.
- » **DHCS PACES Production Environment Effective April 1, 2025.** Starting on and after 4/1/25, production transactions submitted to the DHCS-PACES/Prod folder will receive the updated VRF.

VRF v1.4 Update - Reporting Year and Month

FORMAT: <NetworkDataYearMonth>2412</NetworkDataYearMonth>

- » Represents the reporting period entered in the ISA02 segment in the 274 file.
- » Plans must use this information to ensure the submitted 274 file includes the intended reporting period.
- » If the Reporting Period identified in the VRF is not the intended reporting period, plans must immediately correct ISA02 and resubmit the file.

VRF v1.4 Update - Distinct Group TaxID Count

Format: <DistinctGroupTaxIdCount>10</DistinctGroupTaxIdCount>

- » Represents the total distinct Group Detail records based on the Group Tax ID.
- » Plans must use this information to ensure the submitted 274 file includes all intended Group Detail records.
- » If the Distinct Group count reported in the VRF does not represent the intended Group Detail records, plans must immediately correct and resubmit the file.

VRF V1.4 Update - Distinct Site NPI Count

Format: `<DistinctSiteNpiCount>20</DistinctSiteNpiCount>`

- » Represents the total distinct Site Detail records based on the Site NPI.
- » Plans must use this information to ensure the submitted 274 file includes all intended Site Detail records.
- » If the Distinct Site count reported in the VRF does not represent the intended Site Detail records, plans must immediately correct and resubmit the file.

VRF V1.4 Update - Distinct Provider NPI Count

Format: <DistinctProviderNpiCount>50</DistinctProviderNpiCount>

- » Represents the total distinct Provider Detail records based on the Provider NPI.
- » Plans must use this information to ensure the submitted 274 file includes all intended Provider Detail records.
- » If the Distinct Provider count reported in the VRF does not represent the intended Provider Detail records, plans must immediately correct and resubmit the file.
