## ADVANCE NOTICE OF INTENT TO FILE EMERGENCY REGULATIONS ER-4-13

## TITLE 10: CALIFORNIA CODE OF REGULATIONS CHAPTER 5.5 MAJOR RISK MEDICAL INSURANCE BOARD

NOTICE IS HEREBY GIVEN in accordance with Government Code Section 11346.1(a) (2), which requires that State of California agencies give a five working day advance notice of intent to file emergency regulations with the Office of Administrative Law (OAL). The Managed Risk Medical Insurance Board (MRMIB or Board) intends to file an Emergency Rulemaking package with the Office of Administrative Law (OAL) in order to modify Managed Risk Medical Insurance Program eligibility standards. As required by subdivisions (a)(2) and (b)(2) of Government Code Section 11346.1, this notice appends the following: (1) the specific language of the proposed regulation and (2) the Finding of Emergency, including specific facts demonstrating the need for immediate action, the authority and reference citations, the informative digest and policy statement overview, attached reports, and required determinations.

The Board plans to file the Emergency Rulemaking package with OAL at least five working days from the date of this notice. If you would like to make comments on the Finding of Emergency or the proposed regulations (also enclosed), they must be received by both the Board and the Office of Administrative Law within five calendar days of the Board's filing at OAL. Responding to comments received at this point in the process is strictly at the Board's discretion.
