In addition to amendments proposed to the regulation text that were made to conform to statutory changes enacted through SB 853 (Statutes of 2010, Chapter 717), the Department has prepared supplemental information that describes additional regulation text changes proposed, as follows:

### **Redesignations**

Subsections are redesignated to accommodate additions to and/or deletions from the existing regulation text. The following sections are affected: 52000, 52102 and 52501.

#### **Section 52000(r)**

An amendment was included to this subsection pursuant to SB 853 (Statutes of 2010, Chapter 717). Subsection (r) was redesignated as subsection (w) to maintain the alphabetical order of the definitions under Section 52000.

#### **Section 52100(b)**

A correction was included changing the word “quarter” to “month,” which is consistent with the monthly payment requirement under H&S Code Section 1324.22.

#### **Section 52503**

Corrections were included adding the word “care” to the phrase “direct and indirect care non-labor costs.” The word “care” was inadvertently omitted in the original filing. Sections 52000(m) and 52501(b) both identify the correct use of the phrase “direct and indirect care non-labor costs,” this change makes Section 52503 consistent with these other sections.

#### **Section 52504(i)**

A correction was included that changes the cross reference from “subsection (a)” to “subsection (d).”

#### **Sections 52507(d), (e) and (f)**

Existing subsections (e)(1) through (3) under Section 52506 were redesignated as subsections (d), (e) and (f) under new Section 52507, which is the newly adopted section for Professional Liability Insurance Costs.
