SUBJECT: Administrative Day Rate for Fee-For-Service/Medi-Cal Hospitals for Fiscal Year 2022-23

PURPOSE: This Information Notice communicates to mental health plans the administrative day rate paid to Fee-for-Service Hospitals pursuant to State Plan Amendment 09-004.

REFERENCE: California Code of Regulations, Title 9, [Section 1820.110](#); and Title 22, [Sections 51542](#) and [51511](#)

BACKGROUND:

The rate of reimbursement for administrative day services for Fee-For-Service/Medi-Cal hospitals is determined by the Department of Health Care Services in accordance with Title 9, Section 1820.110(d) of the California Code of Regulations.

POLICY:

*FY 2022-23 COVID-19 Increased Reimbursement Rate for Administrative Day Services*

The Administrative Day rate has changed from \$803.88 to **\$883.71 effective August 1, 2022 until May 11, 2023.**

*FY 2022-23 Reimbursement Rate for Administrative Day Services after the COVID-19 Public Health Emergency Expiration*

The public health emergency for the COVID-19 outbreak expired on May 11, 2023. Thus, effective May 12, 2023 the COVID-19 increased reimbursement rate for Administrative Day services will revert to the Rate Year 2022-23 annual per diem rates. **Effective May 12, 2023, the Administrative Day Rate is \$817.64.**

*Rate for Administrative Day Services for Fee-for-Service and Short-Doyle Medi-Cal Hospitals*

Effective July 1, 2023, the Administrative Day rate for Medi-Cal Fee-for-Service hospitals and Short-Doyle Medi-Cal hospitals will be the same rate, as published in this and future Information Notices.
