The LEA BOP is a Certified Public Expenditure Program that reimburses costs to LEAs (school districts, County Offices of Education (COEs), charter schools, community colleges, and university campuses) for health-related services provided by qualified health service practitioners to Medi-Cal enrolled students. It is extremely important for LEA BOP Providers to comply with the program to receive reimbursements for LEA BOP services. Medi-Cal Eligibility Ratio (MER) Training

DHCS conducted the MER Training for State Fiscal Year (SFY) 2023 – 2024 on September 14, 2023. The training slides are published on the LEA BOP [Training webpage](#).

Action Items for October – December 2023

- CBEDS Census Day
 - As a reminder from the MER Training, LEAs were responsible for extracting a file containing total LEA student enrollment on October 4, 2023. This data must be used for obtaining the Medi-Cal eligibility information by October 31, 2023, through the MOVEit process. Eligibility information from October 2023 is then used to calculate the MER for the SFY 2023-24 CRCS, which is due March 1, 2025. All supporting documentation for this process must be saved for audit purposes.
- Annual Report
 - Due November 30, 2023
- Start of Random Moment Time Survey (RMTS) for SFY 2023-24
 - October 1, 2023, start of the RMTS for SFY 2023-24
 - Update Time Survey Participant (TSP) List for Quarter 3; please work with your Local Educational Consortium's due dates
- Update Targeted Case Management (TMC) practitioner list
 - PPL 20-033 outlines the requirements for identifying TCM practitioners in LEA BOP in RMTS
