With the end of the public health emergency, about 15 million Medi-Cal members will need to renew their Medi-Cal enrollment. The Department of Health Care Services' (DHCS) top goal is to minimize Medi-Cal members' burden and support continuity of coverage and access to equitable, coordinated care. "Keep yourself and your family covered" encourages members to provide updated contact information as they can be contacted with important information on keeping their Medi-Cal benefits. Additionally, Local Educational Agencies (LEA) can use outreach materials from DHCS school toolkit on "[Keep Your Medi-Cal](#)" to help schools and families.
