


**Dental Utilization in Children Ages 0-20**

**Annual Dental Visits**











**Data Source:** Count of providers enrolled in May 2023 who also provided services within the last year in dental offices or SNCs within Los Angeles, Sacramento, and surrounding counties (Orange, Riverside, San Bernardino, Ventura, Yolo, Placer, and El Dorado). FFS provider counts provided by the Administrative Services Organization (ASO) and Provider Application and Validation for Enrollment (PAVE); DMC provider counts provided by DMC plans. Providers are matched with claims for date of services between June 1, 2022 and May 31, 2023, as of July 17, 2023, to identify the county the providers served.
