- Cov me nyuam yaus thiab cov hluas hnuv nyooog 0–20 xyooos
- Yuav tsum nyob rau hauv California
- Tsis muaj cai tau txais Medi-Cal
- Tsis muaj kev pab them nqi ntawm California Children's Services (CCS) rau cov khoom pab kom hnov lus (tuaj yeem thov tau rau tib lub sij hawm tag nrho CCS thiab HACCP)
- Kev xa mus rau kws kho mob/daim ntawv sau yuav khoom pab kom hnov lus
- Tsis muaj kev pab them nqi kho mob lwm yam rau cov khoom pab kom hnov lus los sis muaj is sas las kho mob uas tsuas duav roos tsis pub dhau \$1,500 txog cov khoom pab kom hnov lus.
- Qhov nyiaj khwv tau los ntawm yim neeg tsawg dua 600% ntawm tsoom fwv teb chaws them kev txom nyem (FPL)
