Updates

- » Medi-Cal Managed Care Plans (MCP) must maintain a clinical advisory committee and establish a Family Advisory Committee.
- » MCPs with openings on their family advisory committee or clinical advisory committee are recruiting new Members.

Question for Discussion

- » How can local CCS stakeholders assist with identifying individuals who are interested in participating on these committees?
- » What additional avenues can MCPs pursue to recruit advisory committee members that are not currently being pursued?
 - » DHCS will be reaching out to stakeholders for recruitment suggestions.

2024 WCM Transition Monitoring

2024 Kaiser WCM Monitoring Overview

Kaiser demonstrated operational readiness for the 2024 WCM Transition through submission of 29 deliverables for DHCS's review and approval

- » Kaiser has completed outreach to 100% of out of network (OON) providers.
- » Kaiser's Continuity of Care (CoC) agreement percentage is in line with the statewide percentage for the 2024 MCP Transition.
 - 64% of CoC agreements have been secured with OON providers.
 - 36% of providers were non-responsive or declined to enter into an agreement.
 - DHCS validated this reporting by calling providers directly.
- » The WCM Dashboard details the criteria that all WCM Medi-Cal Managed Care Plans (MCP) will be evaluated on for long term monitoring.
 - Kaiser will be evaluated using that same criteria.
- » Kaiser has demonstrated that they are referring Members to County CCS Programs, assigning case managers to all Members, and completing assessments and care plans.

Kaiser WCM Provider Network

DHCS assessed Kaiser's complete network capacity and determined Kaiser had an adequate paneled provider network to serve the WCM population. This included an assessment of their existing network.

- » Kaiser has a robust network including all required facility types, specialties, and sub-specialties.
- » Kaiser has strong overlap with CCS-WCM providers providing services to WCM Members pre-transition.
 - 100% for paneled providers
 - 92% for Special Care Centers
 - 79% for professional, allied, and medical support providers
 - 63% for Licensed Acute Hospitals
- » Kaiser continued contracting activities through the end of June 2024 with the goal of increasing overlap.
- » Kaiser provides monthly updates to DHCS and promptly addresses any inquiries.

 - » WCM 90 Day Notice – DHCS to mail and to be in hand October 1, 2024
 - » WCM 60 Day Notice – MCPs to mail and to be in hand November 1, 2024
 - » WCM 30 Day Notice – MCPs to mail and to be in hand December 1, 2024
- » The WCM Notices and Notice of Additional Information (NOAI) have been posted on the [DHCS CCS WCM webpage](#). The NOAI will be accessible through a Quick Reference (QR) code on the notices, and a printed copy will also be available via mail upon the member's request as outlined in the notices.
- » MCPs will conduct a Member call campaign from November 1, 2024 - December 1, 2024.

WCM Managed Care Plan Readiness

- » Six deliverables were due May 1st:
 - WCM.0007, WCM.0009, WCM.0010, WCM.0011, WCM.0012, and WCM.0026
 - All six deliverables have been approved for all three plans.
 - In general, all plans were able to receive approvals for these deliverables with their initial submission or after a resubmission once guidance was provided.

WCM Managed Care Plan Readiness

- » Seven deliverables were due in June, six on June 3rd and one on June 17th.
 - WCM.0001, WCM.0004A, WCM.0006, WCM.0014, WCM.0021, WCM.0022, and WCM.0023
 - As of July 8th, most deliverables have been approved.
 - Approvals are still outstanding for at least one MCP each for WCM.0001, WCM.0004A, and WCM.0006.
 - DHCS is pending responses to Additional Requests for Information (AIR) for WCM.0001 (Transition Plan).

WCM Managed Care Plan Readiness

- » DHCS is currently reviewing AIR responses for WCM.0004A (Provider Network) and WCM.0006 (Continuity of Care P&P – Non-Transition).
- » DHCS provided guidance for those which were returned to the MCPs as an AIR.
- » Additional guidance will be provided if needed.
- » Approvals for the remaining deliverables is anticipated soon.

WCM Managed Care Plan Readiness

- » Six deliverables will be due on July 15th:
 - WCM.0015, WCM.0017, WCM.0024, WCM.0025, WCM.0027 and WCM.0028
- » Overall health of Managed Care Plan Readiness is on-track.

WCM County Readiness

- » The WCM County CCS Program Readiness Submission Requirements Checklist was provided to the expansion counties in March and the county readiness review process launched in Quarter 2, 2024.
- » The WCM County CCS Program Readiness Submissions Checklist includes the following deliverables:
 - Operational Transition Plan [due June 3]
 - Policies and Procedures [due June 3]
 - Memorandum of Understanding [due September 30]
- » All June 3rd deliverables have either been received from counties and are under review or extensions were requested and provided.

Collaborative Planning

- » DHCS continues to host monthly joint collaborative planning meetings with the three MCPs and 12 expansion counties. These meetings provide the opportunity for DHCS, the MCPs and the counties to collectively share updates and information, raise questions, and share best practices.
- » DHCS continues to host regular bi-monthly WCM expansion county meetings with the 2025 expansion counties and host office hours to assist them in preparing for the January 1, 2025, transition to WCM.
- » DHCS hosts a monthly deliverables meeting with the MCPs to assist them with any questions they have regarding deliverables.
- » DHCS also continues to organize additional ad hoc meetings with the counties and/or MCPs as necessary to address questions/issues that come up.

Provider Engagement

DHCS Policy Impacting Providers

MCPs will be engaging providers in advance of and immediately following the 2025 WCM transition for contracts, Letters of Agreements (LOAs), and CoC agreements

- » **CoC for Providers** – MCPs will conduct proactive outreach to OON providers currently serving the transitioning population. This will assist MCPs with expansion of their provider networks to serve the transitioning Members long-term and with their network readiness.
- » **Network Readiness**– DHCS is reviewing overlap with the existing provider network and assessing MCPs on paneled providers, allied, professional, and medical support providers, licensed acute care hospitals, special care centers, and durable medical equipment.

Update on Draft ECM Referral Standards and Template and Presumptive Authorization Policy

Streamlining Access to ECM

- » In July 2023, DHCS released a set of Enhance Care Management (ECM) and Community Supports policy refinements focused on improving the standardization of the design of both programs, with the goal of increasing the number of Members served and reducing administrative burden.
- » As part of the Department's July 2023 policy refinement commitments, **DHCS is developing updated ECM referral and authorization standards to streamline access to the benefit.**

Upcoming Guidance on ECM Referrals and Authorizations


- » Universal ECM Referral Standards and Template
 - Streamline and align ECM referral process statewide for all MCPs to support member access to ECM.
- » Updated ECM Presumptive Authorization Policy
 - Expand use of presumptive authorization so specific ECM providers can start serving members faster.
- » Currently in development – DHCS release of Updated Guidance planned for July 2024 with implementation January 2025

CCS Grievance Process

- » CCS grievance process was implemented on July 1, 2024
- » CCS beneficiaries and/or representatives may file a grievance any time for concerns with:
 - » Coordination of care, services, equipment, or appointments
 - » Poor customer service
 - » Discrimination against you or your child
 - » Health information privacy
 - » Quality of care
 - » Referrals for services
 - » Scheduling appointments
 - » Timeliness of service authorizations or CCS program eligibility decisions

County Responsibilities for Grievances

Independent Counties

- » Intakes grievances
- » Acknowledges grievances
- » Resolves grievances
- » DHCS will support counties during the transition period of July 1, 2024, to July 1, 2025, if needed

Dependent Counties

- » DHCS intakes and acknowledges grievances
 - DHCS will send grievances to responsible county for issues under their purview
- » Responsible entity resolves grievances
- » County intake and acknowledge grievances



 - Children's Presumptive Eligibility (CPE) and Newborn Gateway trainings are available today for completion by previously *active* CHDP providers who used Gateway and now wish to participate in CPE. Both are in the [Medi-Cal Learning Portal website](#)

 - MCPs are providing care coordination to all members, conduct ongoing trainings for network providers, conduct provider site reviews and provider site relocations

Authorizing Statute

Assembly Bill 118 and Welfare & Institutions Code (WIC), section 14094.7(b) requires DHCS to conduct the following activities by January 1, 2025:

- » Annually provide an analysis on its website regarding trends on CCS enrollment for Whole Child Model (WCM) counties and non-WCM counties, in a way that enables a comparison of trends between the two categories of CCS counties.
- » Develop utilization and quality measures, to be reported on an annual basis in a form and manner specified by the department, that relate specifically to CCS specialty care and report such measures for both WCM counties and non-WCM counties. When developing measures, the department shall consider:
 - Recommendations of the CCS Redesign Performance Measure Quality Subcommittee established by the department as part of the CCS Advisory Group pursuant to subdivision (c) of Section 14097.17.
 - Available data regarding the percentage of children with CCS eligible conditions who receive an annual special care center visit.

Authorizing Statute (continued)

- » Require, as part of its monitoring and oversight responsibilities, any Whole Child Model plan, as applicable, that is subject to one or more findings in its most recent annual medical audit pertaining to access or quality of care in the CCS program to implement quality improvement strategies that are specifically targeted to the CCS population, as determined by the department.
- » Establish a stakeholder process pursuant to Section 14094.17.

For WCM MCPs results from the measures identified in this process may inform quality improvement efforts.

Measure Development Progress

- » In alignment with the authorizing statute, and in collaboration with the CCS Redesign Performance Measure Quality Subcommittee ("Subcommittee"), DHCS is identifying, selecting, and developing CCS-appropriate performance measures to be included in a publicly available dashboard.
- » The initial iteration of this dashboard will be published no later than January 1, 2025, and will contain presently available demographic data (detailed on the following slide).

Selected Tier 1 Measures

- » DHCS is moving forward with the below six Tier 1 measures, which received over 60% of the Subcommittee's vote. :
 1. CCS Paneled Provider Utilization
 2. Ambulatory Care – Emergency Department (ED) Visits
 3. Inpatient (IP) Admissions
 4. Pediatric All-Condition Readmission
 5. CCS beneficiaries with select conditions who have a documented visit with a SCC within 90-days of referral
 6. CCS Beneficiaries with Hearing Related Condition

Selected Tier 1 Measures (continued)

- » Based on relevance to the CCS population, feasibility of the measures, and data availability, DHCS determined that it is critical to track the two preventive measures below.
 - Childhood Immunization Status (CIS)
 - Immunizations for Adolescents Combination 2 (IMA-2)
- » DHCS will include these measures in Tier 1 in alignment with DHCS's renewed focus on population health, preventative care, and wellness as the foundation of all health care and care navigation.

Summary of Measurement Development Timeline

January 1, 2025
