1. Hnangv haaix yienc naaiv norm kou-gong?

Yiem naaiv California a'zuqc yienc siang-doz-leiz tengx tiuv jau-louc bun meih nyei fu'jueiv zipv tengx gong-bou jau-louc yiem California Children's Services (CCS) ku-gong. Yiem **Zih hlaax saengh 1, 2025** jiex gorn mingh, ninh mbuo Medi-Cal a'zuqc tengx capv cuotv WCM kou-gong jiex ndaangc 12 norm nquenc zangc yiem California. Yiem njiec naaic deix 12 nquenc, ninh mbuo Medi-Cal beu heng-wangc sou-gorn a'zuqc tengx domh goux mangc nzoih gong-bou jau-louc, gunv goux sou-gorn, aengx caux da'nyeic deix California Children's Services (CCS) liouh bun fu'jueiv dungh maaih horpc bouc gaux zipv CCS nyei buonc. Ih zanc meih nyei fu'jueiv a'zuqc duqv zipv CCS yiem njiec ninh mbuo nyei beu zorc baengc sou-gorn yiem njiec nquenc zangc tengx daaih. Aengx maaih norm mbuoz huec Whole Child Model (WCM) kou-gong.

Ndaangc taux ziangh hoc longc naaiv bienh siang-doz-leiz, haaix deix fu'jueiv maaih horpc bouc gaux bieqc CCS nyei buonc yaac duqv zipv tengx ziux goux zorc baengc yiem yi bung siu-gorn dungh maaih bung yiem nquenc zangc CCS kou-gong **aengx caux** maaih bung yiem Medi-Cal beu heng-wangc sou-gorn yiem nquenc zangc dungh haaix norm nquenc mv maaih WCM kou-gong wuov. Ih zanc maaih WCM kou-gong nyei buonc, Medi-Cal a'zuqc borqv nzoih doih tengx ziux goux nzoih yietc zungv gong-bou jau-louc yiem njiec fu'jueiv nyei Medi-Cal beu heng-wangc sou-gorn.

Ih zanc yiem njiec naaiv deix 33 norm nquenc se mbenc ziangx WCM kou-gong mi'aqc: Butte, Colusa, Del Norte, Glenn, Humboldt, Lake, Lassen, Marin, Mariposa, Mendocino, Merced, Modoc, Monterey, Napa, Nevada, Orange, Placer, Plumas, San Benito, San Luis Obispo, San Mateo, Santa Barbara, Santa Cruz, Shasta, Sierra, Siskiyou, Solano, Sonoma, Sutter, Tehama, Trinity, Yolo, aengx caux Yuba.

2. Naaiv norm WCM kou-gong se zeiz haaix nyungc?

WCM kou-gong tengx nzie bun fu'jueiv maaih horpc bouc zipv Medi-Cal yiem CCS nyei gorn zangc, aengx caux ninh mbuo nyei horpc jaa duqv zipv tengx liuc leiz goux zorc baengc yaac faaux, bieqc lorz zorc baengc, aengx caux goux heng-wangc.

3. Ninh mbuo Medi-Cal beu heng-wangc sou-gorn hnangv haaix juangc gong zoux caux WCM kou-gong?

Yiem njienc nquenc zangc maaih WCM nyei buonc, Medi-Cal beu heng-wangc sou-gorn aengx caux nqoi nzuih bun baengc mienh duqv zipv ziux goux zorc baengc bun maaih leiz zipv CCS nyei jau-louc wuov. Domh ndie-sai aengx caux liouc siouv ndie-sai dungh juangc gong zoux caux Medi-Cal beu heng-wangc sou-gorn nyei gong-mienh a'zuqc tengx zoux CCS nyei gong. Naaiv deix domh ndie-sai aengx caux liouc siouv ndie-sai se benx CCS kou-gong nyei mienh tengx juangc zoux gong caux CCS bun baengc mienh. Beiv hnangv baengc mienh qiemp zuqc longc zorc haaix nyungc baengc dungh mv duqv yiem Medi-Cal beu heng-wangc sou-gorn nyei gorn zangc doic wuov, ninh mbuo Medi-Cal beu heng-wangc sou-gorn a'zuqc tengx liuc leiz lorz CCS bun zorc baengc bun baengc mienh ei qiemp zuqc nyei baengc.

4. Yie nyei fu'jueiv corc haih juangc longc dongh dau CCS ndie-sai nyei fai?

Meih nyei fu'jueiv corc haih nzipc jienv lorz ninh mbuo lox nyei CCS ndie-sai ndaangc mv gunv gorngv naaic laanh ndie-sai mv juangc gong caux Medi-Cal beu heng-wangc sou-gorn nyei gorn zangc yaac longx. Naaic taux fu'jueiv nyei CCS ndie-sai gorngv ninh mbuo duqv juangc gong caux fu'jueiv nyei Medi-Cal beu heng-wangc sou-gorn nyei fai. Beiv hnangv CCS nyei ndie-sai duqv juangc gorn zangc gong nyei, meih nyei fu'jueiv yaac nzipc jienv lorz lox ndie-sai mingh hnangv lox. Beiv hnangv mv juangc, meih nyei fu'jueiv corc haih nzipc longc naaic laanh CCS ndie-sai hnangv lox mingh taux 12 hlaax nyieqc a'fai gauh ndaauv mingh. Naaiv diuc gong maaih mbuo heuc, "nzipc jienv ziux goux zorc baengc" (continuity of care). Meih corc haih naaic taux fu'jueiv nyei Medi-Cal beu heng-wangc sou-gorn liouh muangx waa-fienx tipv. Meih nyei fu'jueiv corc haih nzipc jienv lorz ninh mbuo lox nyei CCS ndie-sai ndaangc mv gunv gorngv naaic laanh ndie-sai mv juangc gorn zangc (OON). Meih douc waac lorz taux fu'jueiv nyei Medi-Cal beu heng-wangc sou-gorn aengx caux tov heuc tengx borqv nzipc jienv longc fu'jueiv nyei CCS ndie-sai hnangv lox lauh ndaauv ndongc haaix yaac longx dungh CCS aengx caux fu'jueiv nyei Medi-Cal beu heng-wangc sou-gorn juangc gong zoux wuov.

Beiv hnangv Medi-Cal beu heng-wangc sou-gorn aengx caux nquenc zangc mv haih doi-dongh nor, ninh mbuo a'zuqc fungx nanv sic gunv goux sou-gorn mienh yiem fu'jueiv nyei Medi-Cal beu heng-wangc sou-gorn.

6. Yie nyei fu'jueiv corc haih juangc longc dongh dau CCS nyaanh yiem njiec WCM kou-gong nyei?

8. Naaiv norm WCM kou-gong duqv yienc jau-louc liouh zipv CCS tengx ziux goux zorc baengc nyei?

Naaiv norm WCM kou-gong duqv borqv caux doic tengx ziux goux nzoih yietc zungv gong-bou jau-louc zorc baengc bun fu'jueiv aengx caux taan waa-fienx bun taux fu'jueiv nyei ndie-sai muangx. Ninh mbuo a'zuqc mbungh goux longx bun meih nyei fu'jueiv duqv nzoih yietc zungv gong, lemh jienv CCS gong aengx caux nyungc horng jaa-dorngx yiem caux fu'jueiv nyei Medi-Cal beu heng-wangc sou-gorn. Naaiv norm WCM kou-gong a'zuqc dorh meih nyei fu'jueiv duqv bieqc zipv yiem caux liouc siouv ndie-sai ziux ninh mbuo nyei horpc bouc jau-louc gaux zipv CCS. WCM a'zuqc bun meih nyei fu'jueiv duqv nzipc longc CCS ndie-sai mingh ndaangc.
