SUBJECT: JUVENILE DETENTION FACILITY CONTACTS FOR SENATE BILL 1469
REQUIREMENTS (reference All County Welfare Directors Letter
07-34)

The purpose of this letter is to transmit the list of chief probation officer contacts to county welfare departments (CWD). Counties should contact the appropriate chief probation officer if they need to contact a county juvenile detention facility to carry out the requirements of Senate Bill (SB) 1469. ACWDL 07-34 implemented the requirements of SB 1469 (Chapter 657 Statutes of 2006). That legislation required the Department of Health Care Services to develop a Medi-Cal application process so that juveniles who are incarcerated in specified county detention facilities for 30 days or longer can establish Medi-Cal eligibility immediately upon release if they are determined eligible. ACWDL 07-34 also required counties and juvenile detention facilities to provide points of contact to work cooperatively to implement the requirements of SB 1469. ACWDL 08-36 transmitted contact information for the representatives responsible for the pre-release application process at the CWDs.
