## **D-SNP Deeming Periods**

Medicare Advantage D-SNPs in California are required to maintain enrollment for their members for at least a three-month deeming period upon notification that a member has lost Medi-Cal eligibility. The intent of this policy is to support continued access to providers and care coordination while a member may take steps to restore their Medi-Cal eligibility. D-SNPs provide a deeming period of three to six months.
