FINAL NOTICE OF MONETARY SANCTION FOR FAILURE TO MEET AND EXCEED MINIMUM PERFORMANCE LEVELS FOR MEDI-CAL MANAGED CARE ACCOUNTABILITY SET PERFORMANCE MEASURES

Dear Dorothy Seleski,

The Department of Health Care Services (DHCS) sends this Final Notice of Monetary Sanction Letter to Health Net Community Solutions, Inc. (Health Net) for failure to meet and exceed the required minimum performance levels (MPLs) for measurement year 2024 (MY24)¹ Medi-Cal Managed Care Accountability Set (MCAS) performance measures (Managed Care Plan (MCP) Contract, Exhibit A, Attachment 3, section 2.2 Quality Improvement System, subsection 2.2.9 External Quality Review Requirements).

Under California Welfare and Institutions Code (W&I) section 14197.7 and the MCP contract, DHCS has the authority to impose monetary sanctions for Health Net's failure to meet and exceed required MPLs for MY24, which has directly impacted Health Net's Members (MCP Contract, Exhibit A, Attachment 3, section 2.2 Quality Improvement System, subsection 2.2.9 External Quality Review Requirements). Pursuant to W&I section 14197.7(f) and the MCP contract, DHCS is authorized to impose a \$25,000 sanction per violation of Health Net's contractual obligation to meet and exceed MPLs for each MCAS performance measure (MCP Contract, Exhibit E, Program Terms and Conditions, section 1.1.19 Sanctions; W&I section 14197.7(e)).

Successful administration of the Medi-Cal program requires a collaborative partnership between DHCS and Health Net. This collaboration includes the expectation that Health Net meet their contractual and programmatic requirements on an ongoing basis. DHCS provides Health Net with regular opportunities for collaboration on strategies for

improving Health Net's MCAS performance measures required to meet and exceed MPLs, including engaging directly with Health Net on required Quality Improvement (QI) work, providing QI coaching, and providing opportunities to participate in statewide and regional quality improvement collaboratives.

On April 25, 2025, DHCS published APL 25-007 Attachment C², which provided MCPs with an overview of the MCAS monetary sanction methodology.

On August 21, 2025, DHCS received Health Net's reported MCAS rates through the External Quality Review Organization (EQRO).

On October 7, 2025, DHCS sent Health Net the Quality Sanction Bulletin via the Quality Monitoring Inbox, which provided a detailed overview of MCAS monetary sanction methodology for MY24.

DHCS determined that Health Net has 49 county-level measures below the MPL across four domain(s), triggering Tier 2 or Tier 3 quality sanctions in five county(ies). See Table 2 for enforcement tier designation triggers.

On October 16, 2025, DHCS notified Health Net that DHCS was imposing monetary sanctions in the amount of \$329,000.00 for Health Net's failure to comply with its obligations set forth in the contract. See Table 3 and/or 4 for Health Net's Sanction Determination Details.

Health Net requested a Meet and Confer Conference with DHCS. DHCS and Health Net met on October 31, 2025. DHCS also considered the following information provided by Health Net in conjunction with the Meet and Confer Conference:

- Health Net asked DHCS to consider using a larger county-level denominator for the hybrid measures to be more representative of their MCAS rate performance.
 Health Net provided administrative rates for CBP, CIS-10, LSC, and IMA-2 because of the larger denominator.
 - DHCS recognizes that Plans may need clarification on the minimum county-level denominator for hybrid measures. Sanction determinations were adjusted utilizing the administrative rates for CBP, CIS-10, LSC, and IMA-2.
- Health Net asked DHCS to consider that their MY23 performance rates are not comparable to their MY24 performance rates because of the transition from reporting unit- to county-level reporting. Health Net requested setting the trending

factor to 1.0 for a sanctioned measure when the trending factor was greater than 1.0.

DHCS recognizes the transition from reporting unit- to county-level reporting. DHCS did not apply a trending factor of 1.0 only for the sanctioned measures that had a trending factor greater than 1.0. DHCS is instead applying a single trending factor methodology for all sanctioned MCAS measures. DHCS thus modeled sanction determination using a trending factor of 1.0 for all of Health Net's sanctioned MCAS measures. However, this adjustment would result in a higher sanction amount because Health Net had a trending factor less than 1.0 for other sanctioned MCAS measures. Therefore, DHCS did not make this adjustment.

As a result of the information provided by Health Net in conjunction with the Meet and Confer Conference, the final sanction amount is \$327,000.00, which will be paid to DHCS via ACH/Wire or check payment. Please follow the included payment instructions to effectuate payment in full to DHCS. Please indicate the name of the MCP, MY, and the reason for payment when submitting your payment to DHCS. The effective date of this sanction is November 24, 2025. Payment for the MCAS MY24 Quality Sanctions is due immediately.

If Health Net does not pay within 30 business days, Health Net will receive a past due notice. Please provide notice of receipt and payment via email to DHCS' Quality Monitoring inbox at QualityMonitoring@dhcs.ca.gov. Please include the account number and check number, or wire transfer number, once payment has been sent. Notice of Appeal Rights is included in the letter below.
