


DENTAL UTILIZATION IN CHILDREN

CY 2019 - CY 2023 Utilization for Eligibles 0 to 20








Figure 4: Preventive Services by Month for Members ages 0-20

January - December Utilization for Eligibles 0 to 20




Figure 5: Sealants by Year for Members ages 6-9

CY 2019 - CY 2023 Utilization for Eligibles 6 to 9




Figure 6: Sealants by Month for Members ages 6-9

January - December Utilization for Eligibles 6 to 9




Figure 7: Sealants by Year for Members ages 10-14

CY 2019 - CY 2023 Utilization for Eligibles 10 to 14





Figure 8: Sealants by Month for Members ages 10-14

January - December Utilization for Eligibles 10 to 14



Annual Dental Visits - Annual CY 2019 - CY 2023 Utilization for Eligibles 21+









Figure 12: Preventive Services by Month for Members ages 21 and older


