Instructions for Completion

- This Template is for New Applicants Only. Expansion Applicants will provide proposed Second Round Budget by revising their Approved First Round Budget document.

- Applicant must complete the input cells on the "Summary" tab as well as the detailed budget items on each "PY" tab
- Applicant can add additional rows in the individual "PY" tabs for each major budget section as necessary to capture all requested budget items. **Only insert rows inside rows highlighted in green in order to preserve formulae that populate the summary**
- Applicant should only enter data in cells that are highlighted in green, cells in gray are autopopulated
- All amounts must be entered in whole dollars
- Applicant must ensure that the requested budget amounts add to the appropriate totals for each year and in total across the 5 years. Error checking cells are located on the "Summary" and individual "PY" tabs to assist in ensuring compliance. All errors must be corrected and error checks showing "OK" prior to submission
