

What is Covered?

- » Hearing aids, including assistive listening devices (ALD) and surface-worn bone conduction hearing aid devices (BCHD) or bone anchoring hearing aids (BAHA)
- » Supplies, including ear molds and hearing aid batteries
- » Medically necessary hearing aid accessories
- » Hearing aid-related audiology and physician services

Who is Eligible? What is Covered? How Can Families Apply?

Your child may be eligible for hearing aid assistance through the Hearing Aid Coverage for Children Program (HACCP).

Who is Eligible?

- » Children and youth under age 21
- » Current resident of California
- » Household income under 600% of the federal poverty level (FPL)
- » Provider referral/hearing aid prescription
- » Child or youth:
 - is not eligible for Medi-Cal
 - does not have California Children's Services (CCS) coverage for hearing aids (can apply at the same time for both CCS and HACCP)
 - does not have any other health insurance coverage for hearing aids, or has coverage limited to a maximum of \$1,500

Annual FPL Guidelines

FPL guidelines are updated each year and are calculated based on the number of qualifying family members in your household including parent(s).

The Program Income Eligibility Comparison shows the current maximum annual income (in dollar amounts, by household size) eligible for each of DHCS' health coverage programs that include hearing aid coverage: CCS, HACCP, and Medi-Cal.

2. Include all required documentation:
 - » Household income
 - » Existing health insurance coverage (if any)
 - » Provider referral or hearing aid prescription
