This executive order seeks to address public safety concerns related to homelessness, substance use, and mental health by shifting federal policy away from "Housing First" approaches. The order directs federal agencies to support states in expanding civil commitment and institutional treatment for individuals who pose risks to themselves or others or cannot care for themselves, while increasing enforcement against street encampments and vagrancy. It also realigns funding priorities toward evidence-based treatment programs and imposes stricter accountability measures on homelessness assistance initiatives.

The Continuum of Care (CoC) Notice of Funding Opportunity (NOFO) is HUD's annual competitive funding opportunity that supports local efforts to address homelessness. It provides grants to nonprofit organizations, local governments, and housing agencies to deliver services such as Permanent Supportive Housing, Rapid Re-Housing, transitional housing, and coordinated entry systems.

The Fiscal Year (FY) 2025 COC NOFO signifies a significant shift in funding priorities, focusing on transitional housing and supportive services rather than traditional "Housing First" projects. It aims to ensure transparency and accountability in funding decisions, with approximately \$3.9 billion available to support individuals experiencing homelessness.

### Key Dates:

- **November 13, 2025:** HUD released FY 2025 COC NOFO.
- **December 8, 2025:** HUD withdrew FY 2025 COC NOFO.
- **December 19, 2025:** HUD reissued the FY 2025 COC NOFO with significant changes for "public review," noting that HUD cannot implement or enforce the reissued NOFO until further court order.
