SUBJECT: Senate Bill 75 (Chapter 18, Statutes of 2015) Paid Claims Report Retrieval

With State General Funds (SGF), the Department of Health Care Services (DHCS) reimburses mental health plans (MHP) one hundred percent of the approved amount for specialty mental health services provided to beneficiaries enrolled in Medi-Cal through Senate Bill (SB) 75 (Chapter 18, Statutes of 2015). SB 75 provided that children under 19 years of age are eligible for full scope Medi-Cal benefits regardless of immigration status as long as they meet all other eligibility requirements. MHPs need to report services provided to SB 75 beneficiaries separately in the annual cost report to allow DHCS to ensure it reimburses those costs with SGF. DHCS enrolls these beneficiaries into the Medi-Cal program using full scope aid codes that are not unique to the SB 75 population. Along with the beneficiary's age and aid code, DHCS uses data from the Medi-Cal Eligibility Data System (MEDS) to identify beneficiaries enrolled through SB 75 when adjudicating claims. DHCS has not yet provided MHPs access to these data elements in MEDS. As a result, MHPs are not able to identify services provided to beneficiaries enrolled in Medi-Cal through SB 75. To assist counties with identifying these services in Fiscal Year 2015-16 and Fiscal Year 2016-17, DHCS prepared for each county a report of approved claims. This Information Notice provides guidance to all MHPs on how to access and retrieve these reports.

The paid claims reports have been posted to the DHCS Information Technology Web Services (ITWS) website. ITWS can be accessed via the following link: <a href="https://itws.dhcs.ca.gov/default.asp">https://itws.dhcs.ca.gov/default.asp</a>.

The reports can be accessed by following the steps below:

- 1. Log into ITWS.
- 2. Under the *Systems* tab drop-down menu, and within the Department of Mental Health heading, click on *Short-Doyle/Medi-Cal Claims EOB.*
- 3. Under the *Functions* tab drop-down menu, click on *Transfer files (Upload and Download)*. and
- 4. Scroll down in the list of file links on the left to look for the County's Senate Bill 75 paid claims report. Alternatively, the file can be searched using the keyboard shortcut (Control + F) and enter keyword, *Senate* in the search box. The file has the following format: CNTYXX\_SenateBill75claims\_FY20XX.zip
