

ADVICE (45 CFR PART 162)

The purpose of this Information Notice is to provide 2018 updates to the adjustment codes for denied claims reported on claim payment/advice transactions (835) from the Short Doyle Medi-Cal system. These changes are part of the Committee on Operating Rules for Information Exchange (CORE) Rule 360, which are federally mandated as part of the Affordable Care Act, and had an implementation date of June 5, 2018. Information Notice 15-041 provided background on the Claim Adjustment Reason Codes (CARC) and the Remittance Advice Remark Codes (RARC).

To implement the CORE Rule 360 requirements, the CARC/RARCs have been changed in accordance to the enclosures for Specialty Mental Health Services (Enclosure 1), effective June 5, 2018. For certain claim denials, the description of the circumstance of claim denial was revised from the previously published descriptions to

clarify the circumstance or to reflect the changes since the description was previously published.¹
