### II. Director Remarks and July Meeting Recap Susan Philip, Deputy Director Health Care Delivery Systems

Meeting participants and the Advisory Group members were thanked for attending and for working with the DHCS to provide input, valuable perspective, and for offering suggestions to continue improving the CCS program. October is the last Advisory Group meeting for the 2023 year.

Senate Bill (SB) 544, Bagley-Keene Open Meeting Act, is currently pending approval. If approved, SB 544 would require CCS Advisory Group meetings to provide an in-person meeting option. DHCS has decided that regardless of the outcome, both virtual and in-person attendance options will be offered starting January 2024. More information will be shared prior to the January 10, 2024, meeting. The 2024 quarterly meeting schedule is posted on the <a href="Advisory Group (ca.gov">Advisory Group (ca.gov)</a>) webpage.

The meeting agenda topics were shared noting appreciation for the collaborative discussions between DHCS, Kaiser, and the counties to make the Kaiser implementation as smooth as possible for CCS families.

In closing, it was announced that Jacey Cooper, State Medicaid Director and Chief Deputy Director for Health Care Programs, is leaving DHCS in October to join the federal Centers of Medicare & Medicaid Services. Various Advisory Group members expressed their best wishes to Jacey and wished her well.

#### III. Policy Initiatives

CCS Monitoring and Oversight updates were given. A Memorandum of Understanding (MOU), between DHCS and the county CCS programs was released for public comment from September 26, 2023, to October 11, 2023. The MOU includes a supporting roles and responsibilities table for each county model, and related guidance documents. The MOU will be executed on or before July 1, 2024.

The current status and next steps for the following Numbered Letters (NLs) was provided: Grievance, Appeals and State Hearing, CCS Program Reporting and Survey, Training and Electronic Visit Verification were provided. # IV. Child Health Disability Prevention (CHDP) Program Transition Sabrina Atoyebi, Branch Chief Medical Operations Branch

The CHDP program will transition on July 1, 2024. The transition plan was released for public comment on September 27, 2023, through October 11, 2023, and will be posted on the DHCS website by December 31, 2023. Training, communication, and guidance documents will continue to be released throughout the transition period. #### V. CCS Redesign Performance Measure Quality Subcommittee Sabrina Atoyebi, Branch Chief Medical Operations Branch

Updates were provided for the subcommittee goals and authorizing statue to identify and create an actionable plan to implement metrics that could be applied to both CCS Classic and Whole Child Model (WCM) programs. The next committee meeting is scheduled for November 29, 2023, and will focus on guiding principles for measure selection, domains, preliminary discussion of feasible measures by domain, and the measure selection process. # VI. WCM Readiness: DHCS Updates Joseph Billingsley, Assistant Deputy Director Health Care Delivery Systems

Joseph Billingsley provided DHCS updates on WCM readiness. Kaiser has been authorized by Assembly Bill (AB) 2724 (Chapter 73, Statutes of 2022) to

implement as a WCM plan in the following eight (8) WCM counties in which it will operate effective January 1, 2024. The counties are Marin, Napa, Orange, San Mateo, Santa Cruz, Solano, Sonoma and Yolo.

DHCS provided 28 WCM plan readiness deliverables list to Kaiser on June 30, 2023, including, but not limited to, continuity of care, member notices, provider network, pediatric health risk assessment, maintenance and transportation, beneficiary outreach and access to durable medical equipment. Kaiser has been proficiently meeting the due dates and has been responsive to requests for additional information.

Planned WCM implementation for 2025 is authorized by Assembly Bill (AB) 118 (Chapter 42, Statutes of 2023) for expansion into twelve (12) new County Organized Health System (COHS) counties effective January 1, 2025. Central California Alliance for Health will implement as a COHS plan in Mariposa and San Benito Counties. Partnership HealthPlan of California will expand as a COHS plan into Butte, Colusa, Glenn, Nevada, Placer, Plumas, Sierra, Sutter, Tehama and Yuba counties.

AB 118, in line with AB 2724, authorizes Kaiser to implement as a WCM plan in four (4) COHS expansion counties(Mariposa, Placer, Sutter and Yuba).

# VII. Enhanced Care Management (ECM) Dr. Palav Babaria, Chief Quality and Medical Officer and Deputy Director Quality Population Health Management

Dr. Babaria provided an update on the implementation of ECM for the CCS population of focus benefit that went live July 1, 2023. MCPs will submit data 45 days after the quarter closes. The first data set is expected by mid-November 2023 (i.e., enrollment by sub-population of focus, where gaps or issues may exist) and an update will be provided at the next meeting in January.

DHCS has met with stakeholders and the MCPs to get feedback toward the goals of reducing administrative burden and improving referral pathways. There was a revised policy and multi-pronged approach instituted over the summer to help streamline a number of these pieces. A standardized referral form and process across the State will be rolling out for ECM in 2024. Members expressed concern with ECM administrative challenges and noted there may not be enough pediatric providers available. Dr. Babaria noted more

# VIII. WCM Readiness: Kaiser Update Kayce Velarde, Executive Director, California Medi-Cal and State Sponsored Programs Kinisha Campbell, Executive Director, Medi-Cal Care Coordination Kaiser Permanente

Kaiser Permanente (Kaiser) provided updates on their case management structure and member/community engagement. Kaiser will send transition notices to appropriate members 60 and 30 days in advance of the January 1, 2024, transition. Notices are planned for November 1, 2023, and December 1, 2023, respectively. Existing WCM CCS children with a pre-established relationship with Kaiser will automatically transition to Kaiser on January 1, 2024, with no disruption of care for these members. Those WCM children with no current Kaiser relationship will not automatically transition.

Members also inquired about Kaiser's network adequacy. Updates on network adequacy will be provided at the next meeting in January. Please refer to the posted PowerPoint presentation (<a href="Past Meeting Materials">Past Meeting Materials</a> (ca.gov)) for more information about Kaiser readiness.

#### IX. WCM Readiness: County Perspective Lael Lambert, CCS Administrator Marin County

Lael Lambert, representing Marin, Napa, Solano, Sonoma and Yolo Counties, provided an update on their collective feedback on the successes and challenges of implementing the WCM program, and how they are working with Kaiser to prepare for the January 1, 2024, implementation of Kaiser as a WCM health plan. These counties have met four (4) times with DHCS and Kaiser, and four (4) times with Kaiser since July 2023. During these meetings the parties have discussed how are children identified as CCS/MTU both at the referral and for ongoing case management, and what the definition of case management is. The counties meet

with Kaiser for two (2) hours every two (2) weeks and with DHCS monthly. Going forward the counties are focused on agreement of definitions, policies, and roles/responsibilities, the WCM MOU and establishing clinical and parent advisory meetings, and individual county meetings with Kaiser.

### Dr. Anand Chabra, Medical Director San Mateo County

Dr. Anand Chabra provided an update on San Mateo County's relationship with Kaiser. Prior to 2013 the relationship was limited to Medical Therapy Unit (MTU), Durable Medical Equipment (DME), orthodontia, and special care services outside the Kaiser system. Through the CCS Pilot (2013 to 2018) and WCM implementation (2018 – present) the Medical Therapy Conference relationship has continued with Kaiser and now a Kaiser pediatric specialist and non-clinical representative take part on the CCS Clinical Advisory Committee. A helpful aspect of the relationship with has been having access to the Kaiser EPIC portal. CCS San Mateo staff and Kaiser representatives meet quarterly to check-in, address problems and ensure good communication.
