#### State Budget Policy Updates

- » Pursuant to the enacted <u>2025-26 State Budget</u>, the Department of Health Care Services (DHCS) will be implementing a series of Medi-Cal Rx policy updates to:
  - Reduce pharmacy spending,
  - Improve program integrity, including addressing fraud, waste, and abuse,
  - Ensure continued, equitable access to medically necessary, high-quality pharmacy benefits and services.
- » Changes will be effective on January 1, 2026.
- » As some will have no impact to the pediatric population, we will focus only those proposals that do have an impact.

### Step Therapy for Select Medications

- » Part of the existing utilization management, including prior authorization (PA) request review process.
- » Providers may be asked for additional justification for unlisted Contract Drug List (CDL) medication approval.
- » Not expected to impact California Children Services (CCS) Panel Providers who currently have authority to prescribe most medications without a prior authorization.
- » Providers without CCS Panel Provider status will need to submit justification for use of a non-CDL product when requesting prior authorization approval. Continuing care will not be sufficient justification.

## **Changes to Continuing Care for Select Products**

- For medications that had been on the CDL, but are no longer included, continuation of therapy will not be automatically granted.
  - These medications will now require a prior authorization for medical necessity.
- » CCS Panel Providers who have Panel Authority will not be impacted assuming the claim is not denied for other UM edits such as quantity or cost limits.
- For non-paneled CCS providers:
  - Prior Authorizations for non-CDL medications will be required, even when the member has a history with that medication while it was on the CDL.
- » DHCS will issue letters to impacted members to inform them of the change in coverage.
- » For the lists of drugs, refer to the State Budget Policy Updates tab on the Medi-Cal Rx Education and Outreach webpage.

# Coverage for Over-the-Counter (OTC) Covid-19 Antigen Tests

- » OTC Covid-19 Antigen Tests will require prior authorization approval for Medi-Cal Rx coverage.
  - Prior Authorization requests are for one-time only approval and restricted to up to 4 tests per member, per 30 days.
  - Medical necessity must demonstrate a clinical need for testing.
- » When prescribed by CCS Panel Provider with Panel Authority, no prior authorization will be required.

#### **Exclusion of GLP-1 Drugs for Weight Loss**

- » GLP-1 drugs indicated for weight loss and weight loss-related indications will be excluded from Medi-Cal Rx coverage for all Medi-Cal members.
- » GLP-1 drugs indicated for Type 2 diabetes or other nonweight loss related indications will continue to be a benefit with an ICD-10 code diagnosis.
- » DHCS will issue letters to all members to inform them of the change in coverage.

#### Medi-Cal Rx Operational Updates

- »Implementation of a "Clinical Literature Repository" for citation of clinical literature in Prior Authorization requests – eliminates need to upload articles with Prior Authorization request submission
- »Confirmation of holistic review of prior authorization requests to enable override of cost limit when approving exemption from quantity limit for medical necessity – eliminates need for multiple prior authorizations

# Support for Members Aging Out of Pediatric Care

- » DHCS is exploring a policy change to allow prescriptions written by CCS Panel Providers with Panel Authority, for any pediatric member, to be eligible for a 100-day prior authorization extension when the member becomes 21 years of age.
  - This provides a grace period while the member establishes relationship with an adult care provider.
  - This policy also aligns with the intent of the CCS Panel Provider Authority – to recognize the status of paneled providers and eliminate administrative burden for those caring for the most vulnerable pediatric patients.
