SUBJECT: CORRECTION OF COUNTY SHARE OF COSTS RESULTING FROM A
DUPLICATE CCS CHECKWRITE THAT OCCURRED IN JANUARY 2012

In January 2012, we advised you that there was an error in the CCS-Only checkwrite for the warrant date of January 20, 2012, that resulted in the overpayment of providers. A second, duplicate payment of the claims originally paid on the previous checkwrite occurred. The duplicate payments appeared on the MR-0-940 monthly paid claims report dated January 22, 2012.

These duplicate payments were recovered by the fiscal intermediary using an Accounts Receivable (AR) process. The ARs were liquidated as new claims from the providers who received duplicate payments were received and adjudicated. Unlike the erroneous payment correction (EPC) process, AR recoveries do not appear as credits on a MR-0-940 report. Therefore, now that the AR process is completed, an alternative process for adjusting county share costs incurred by the counties as a result of the duplicate checkwrite is necessary.

The attached table based on paid claims data extracted from the January 22, 2012, MR-0-940 report provides documentation (by county) of the county share of the duplicate payment. The amount shown for each county in the column labeled "County Share of Duplicate Payment" will be credited to your county by the Systems of Care Division, Program Support Unit. This adjustment will be made to your Fiscal Year 2013-14 second quarter CCS Diagnostic/Treatment/Therapy Invoice at the time that invoice is adjudicated by the Program Support Unit.
