CCS Information Notice: 15-14

TO: ALL LOCAL COUNTY CALIFORNIA CHILDREN SERVICES (CCS) PROGRAM AND GENETICALLY HANDICAPPED PERSONS PROGRAM (GHPP) STAFF, CCS MEDICAL CONSULTANTS, COUNTY MEDICAL STAFF, AND SYSTEMS OF CARE DIVISION (SCD) STAFF

SUBJECT: ADDITIONAL PEDIATRIC MULTIVIAMIN SUPPLEMENT NOT PAYABLE IN THE MEDI-CAL BILLING SYSTEM

The purpose of this information notice is to communicate that the State has identified additional pediatric multivitamin supplements deemed a non-covered benefit by the Medi-Cal Program. Because the CCS Program and GHPP utilize the same billing system, claims for these products, when submitted by their 11-digit National Drug Code (NDC) billing codes, will be denied even with an authorized Service Authorization Request (SAR).

Earlier, CCS Information Notice 14-19 identified similar products made non-payable in the Medi-Cal billing system.

Effective for dates of service on or after January 1, 2016, the following products will no longer be reimbursable when billed by its 11-digit NDC number, even with a valid Service Authorization Request (SAR):
