I am pleased to inform you that your request to amend the California Section 1915(c) Home and Community-Based Services Assisted Living Waiver (ALW) has been approved. The amendment has been assigned Control Number 0431.R02.02 and is approved with a July 1, 2018 effective date.

This amendment allows the Department of Health Care Services to increase waiver slots by 2,000 in Waiver Year 5, update the cost neutrality demonstration to account for the increase in waiver slots, and to update their selection of entrants to the waiver by increasing the current enrollment ratio so that more individuals transitioning from institutions are prioritized entry into the waiver. The following services continue to be offered through the ALW waiver: assisted living services – homemaker, home health aide, personal care; care coordination; residential habilitation; augmented plan of care development and follow-up; and nursing facility transition care coordination.

It is important to note that CMS' approval of this waiver solely addresses the state's compliance with the applicable Medicaid authorities. CMS' approval does not address the state's independent and separate obligations under federal laws including, but not limited to, the Americans with Disabilities Act, Section 504 of the Rehabilitation Act, or the Supreme Court's Olmstead decision."
