#### **Purpose of Today's Stakeholder Webinar**



- Present an overview of the Supplemental Funding available to MFP\* state grantees along with CMS' goals
- Introduce DHCS' preliminary concepts for utilizing a portion of the funds to identify opportunities for enhancing and expanding Managed Long-Term Services and Support (MLTSS) capacity

\* MFP is known as California Community Transitions (CCT) in California.

#### MFP Supplemental Funding Opportunity Overview



MFP Supplemental Funding Opportunity Overview

- CMS announced supplemental funding of up to \$165 million for states currently operating MFP Demonstration Programs.
- Each state is eligible to receive \$5 million for planning and capacity building activities to accelerate long-term care system transformation design and implementation, and to expand HCBS capacity.



#### MFP Supplemental Funding Opportunity Overview

- The funding may also be used to support HCBS planning and capacity building in direct response to the COVID-19 public health emergency, examples include, but are not limited to:
  - Planning and implementing telehealth for nursing facility transition activities
  - Redesigning service delivery models to reduce the risk of COVID-19 infection among MFP participants
- States must develop and submit a proposal to CMS to describe how the supplemental funding will be used to fulfill the objectives of the award.

## CMS Goals and Objectives

CMS provided examples on ways states could use the supplemental funding, which includes, but is not limited to:

- 1. Addressing HCBS system and network capacity needs and determining the extent to which states can enroll new providers and expand provider types and/or services.
- 2. Identifying new strategies to increase community transitions.
- 3. Identifying and implementing a streamlined intake and enrollment process to align with the state's No Wrong Door (NWD) efforts.



#### CMS Goals and Objectives Cont.

- 4. Developing and implementing statewide training to increase MFP transitions, improve intake and enrollment processes, and expand services available through the HCBS LTSS systems.
- 5. Creating a statewide critical incident reporting system and process for all HCBS programs.
- 6. Building Medi-Cal housing partnerships.
- 7. Integrating of Information Management System improvements.
- 8. Assessing the need to increase provider rates.



#### Preliminary Funding Proposal Concepts



#### Align with Statewide Initiatives

 In developing the funding proposal, we want to account for and align with groundwork that was created through other stakeholder engagement efforts and initiatives, including the California Master Plan on Aging and California **Advancing and Innovating Medi-Cal** (CalAIM)

#### Conduct an HCBS and MLTSS Gap Analysis

- Commission a statewide gap analysis study to develop a multi-year roadmap for implementing strategies and solutions for strengthening HCBS and MLTSS programs and provider networks
- Examine California's HCBS/MLTSS delivery system to identify opportunities for leveraging existing infrastructure to create a more efficient, comprehensive, and coordinated HCBS and MLTSS delivery system



#### Conduct an MLTSS Gap Analysis

- Opportunity to build upon work already being accomplished through the California Master Plan on Aging, CalAIM, and other current and preceding stakeholder initiatives, including:
  - Milliman's Long Term Services and Supports Feasibility Study
  - Long Term Care at Home Concept
